<u>Section 1.</u> The educational support personnel employee(s) set forth on the attached <u>Exhibit 1</u> will be honorably dismissed effective as of December 15, 2025.

Section 2. The President and Secretary of the Board of Education are hereby authorized and directed to give each educational support personnel employee written notice of the honorable dismissal, in the form attached hereto as Exhibit 2 and incorporated herein by this reference, and stating the reason(s) for such reduction, by U.S. First Class mail and certified mail, return receipt requested, at least thirty (30) days before the effective date of reduction.

<u>Section 3.</u> The Superintendent or designee will also personally deliver a copy of said notice to the educational support personnel employee.

<u>Section 4.</u> This Resolution will be in full force and effect forthwith upon its adoption.
