\$400 per month in lieu of payment if employee opts out of our group health insurance plan

\$1000 'seed' money paid in January

\$1000 'match' for single plan paid over 26 pay periods

\$1500 'match' for double plan paid over 26 pay periods

\$2000 'match' for family plan paid over 26 pay periods

### Open enrollment 2025 healthcare benefits:

#### 911 Dispatchers Union

- \$400 per month in lieu of payment if an employee opts out of our group health insurance plan per union contract
- No HSA 'seed' money for 2025
- Flat (same rate for single, double and family plans) \$800 'match' for the HSA contributions paid over 26 pay periods

# District Court, COAM, Corrections, TPOAM, Deputies, Nonunion

- \$300 per month in lieu of payment if an employee opts out of our group health insurance plan (LoU for unions)
- \$500 'seed' month with half (\$250) to be paid out in January and half (\$250) to be paid out in July
- Flat (same rate for single, double and family plans) \$1000 'match' for the HSA contributions paid over 26 pay periods

The in lieu of payments are under contract with the Unions. District Court, COAM, Corrections, TPOAM and Deputies all agreed to a LoU for 2025 to reduce their in lieu of to \$300 per month.
