#### **IMMUNIZATION REMINDER**

Oregon law added new requirements for immunizations in 2008 – 2009. Your 7<sup>th</sup> grade student should have one additional vaccine by January 2015. An appropriate medical or nonmedical exemption is also acceptable.

Please check your child's records to be sure that he/she has the received the Tdap Vaccine. This vaccine offers adolescents and adults protection against tetanus, diphtheria and pertussis (whooping cough).

If your child has not received the Tdap shot, contact your child's doctor or call Josephine County Health Department at (541) 454-5325. Please give all updated immunization information to your school prior to winter vacation or as soon as your child receives the Tdap shot.

Exclusion date this school year is February 18, 2015.
