Mrs. Conway discussed the name of the preschool and they are thinking about calling it Little Raiders University.

## VII. SPANISH – MIDDLE SCHOOL CURRICULUM

Dr. Conway stated that they still do not have a formal curriculum and he researched Rosetta Stone. A three year agreement would be \$10,900/per year. Edgenuity would not cost anything to open the module for Spanish. Dr. Conway asked the Board if they would like to move forward with Rosetta Stone at \$11,000 per year or if they would like to open up the module in Edgenuity at no cost.

Dr. Conway requested that the Board motion to open Spanish I and II at the Middle School only.

Mrs. Harris motioned to allow the district to utilize Edgenuity at the middle school for Spanish I and II. Mr. Stadt seconded and the motion carried.
