

The Board of Trustees of the Midway Independent School District held a meeting on January 20, 2026 at 7:00 p.m. in the Board Room of the Midway ISD Administration Building located at 13885 Woodway Drive, Woodway, TX 76712. 1. Call to Order

President Vick called the meeting to order.

2. Welcome and District Mission Statement

The District Mission statement was presented to the public.

3. Moment of Silence

A moment of silence was observed.

4. Pledge of Allegiance

5A. January Recognition Days

Dr. Allen acknowledged January as School Board Recognition Month and National Mentoring Month.

5B. National Board-Certified Teachers

The Board congratulated four newly certified National Board-Certified Teachers (NBCTs): Angela Brown (HE), Christy Baish (PHE), Josh Dietert (MHS), and Sharon Cramer (PHE). Midway ISD now has 20 NBCTs district wide.

5C. Texas School Board Recognition Month

Dr. Allen read the Governor of Texas' Proclamation acknowledging January as School Board Appreciation Month. Midway ISD is grateful for the seven elected trustees who bring decades of leadership experience to our schools as parents and alumni. We thank them for their commitment to public education and to the Midway community.

7. Information Items

7A. Quarterly Investment Report

The Quarterly Investment Report was included in the board packet.

7B. Amendments to District of Innovation Plan

Due to changes in law that came about due to the 89th legislative session, the administration recommends amendments to the current plan. The proposed amendments encompass the following areas: Campus Behavior Coordinator, Ejection of Individuals from Facilities, Mandatory DAEP Placement for non-THC E-cigarettes, Suspension of 3rd grade and below and Grievances related to timeline. The DoI Plan amendments will be a Consent Item at the February Board Meeting.

8. Presentation/Discussion Items

8A. Monthly Finance Report

Wesley Brooks, Assistant Superintendent for Finance, presented the monthly finance report. The financial reports indicated a favorable budget outlook with a reduced deficit budget of \$2.8 million compared to the budgeted deficit of \$3,491,000. This is due to revenues projecting \$300,000 higher than budgeted and expenditures projecting \$400,000 lower.

8B. Senate Bill 11: Designated Prayer & Scripture Reading Time

Dr. Allen presented the information regarding Senate Bill 11 which designates prayer and scripture reading time in public schools. The law requires school districts to take a record vote by March 1, to either establish a daily time for prayer and the reading of religious scriptures or decline establishing such a time. The Board will take action during the February meeting.

8C. MISD Marketing Update

Emily Parks, Director of Communications, provided a high-level overview of Midway ISD's marketing efforts, highlighting a strategic shift from a traditional communications focus to a split marketing and communications focus. This strategy is designed to bolster enrollment and recruitment through data-driven digital engagement and storytelling.
