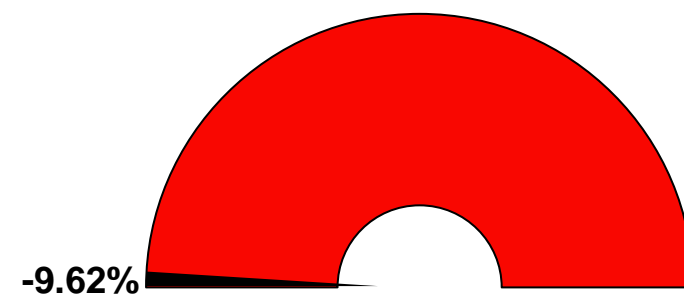

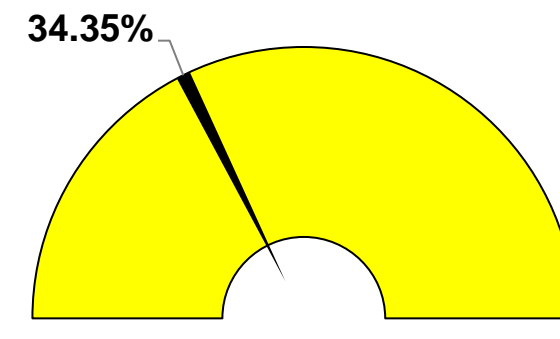

as % of Budgeted Revenues

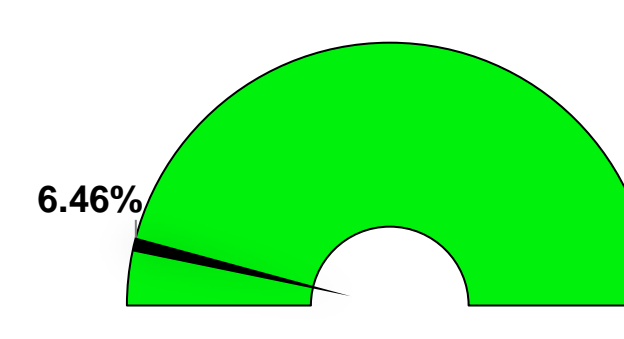

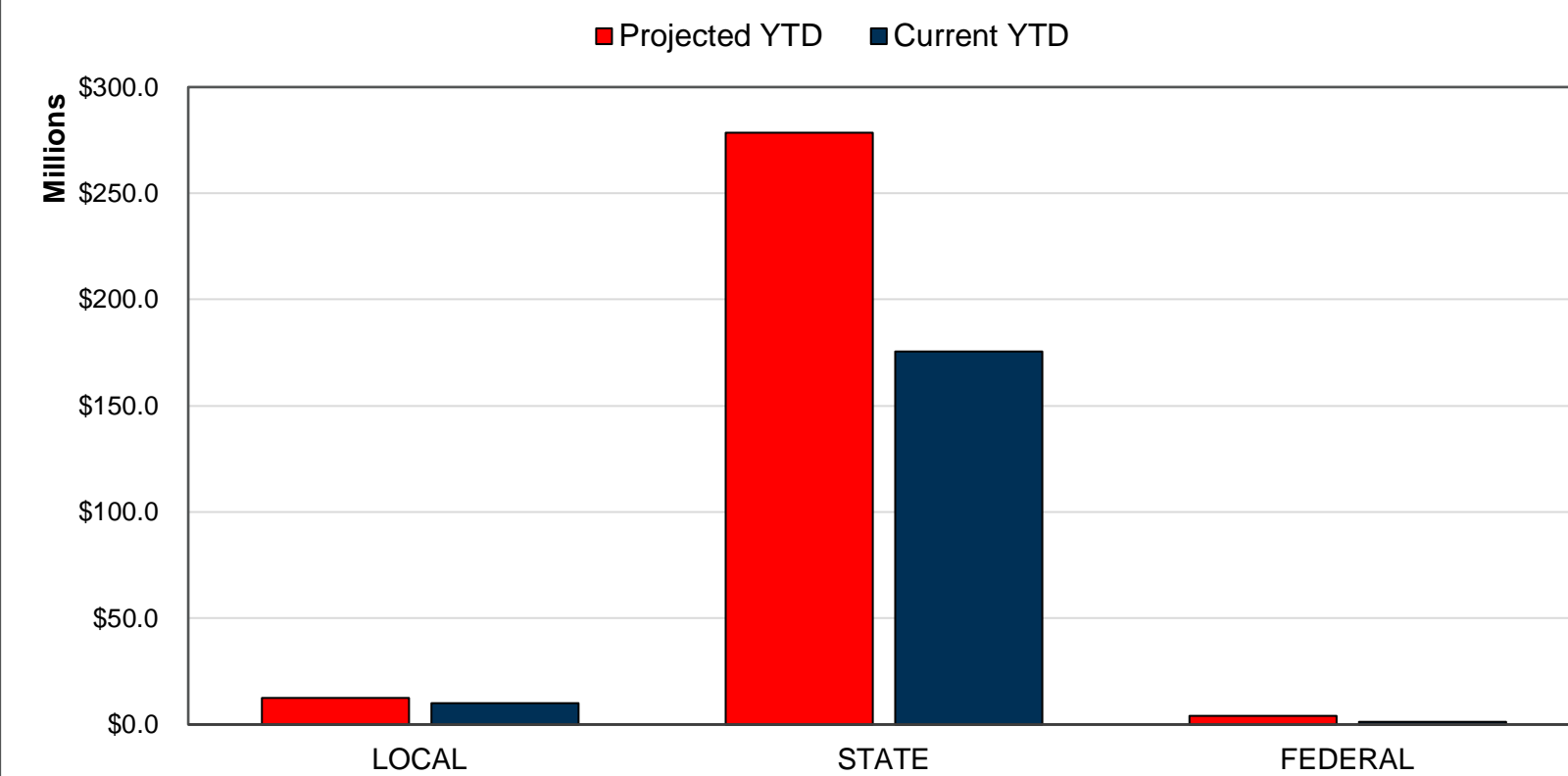

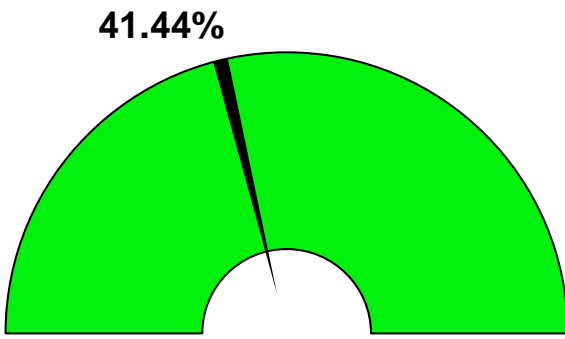

Expenditure Comparison

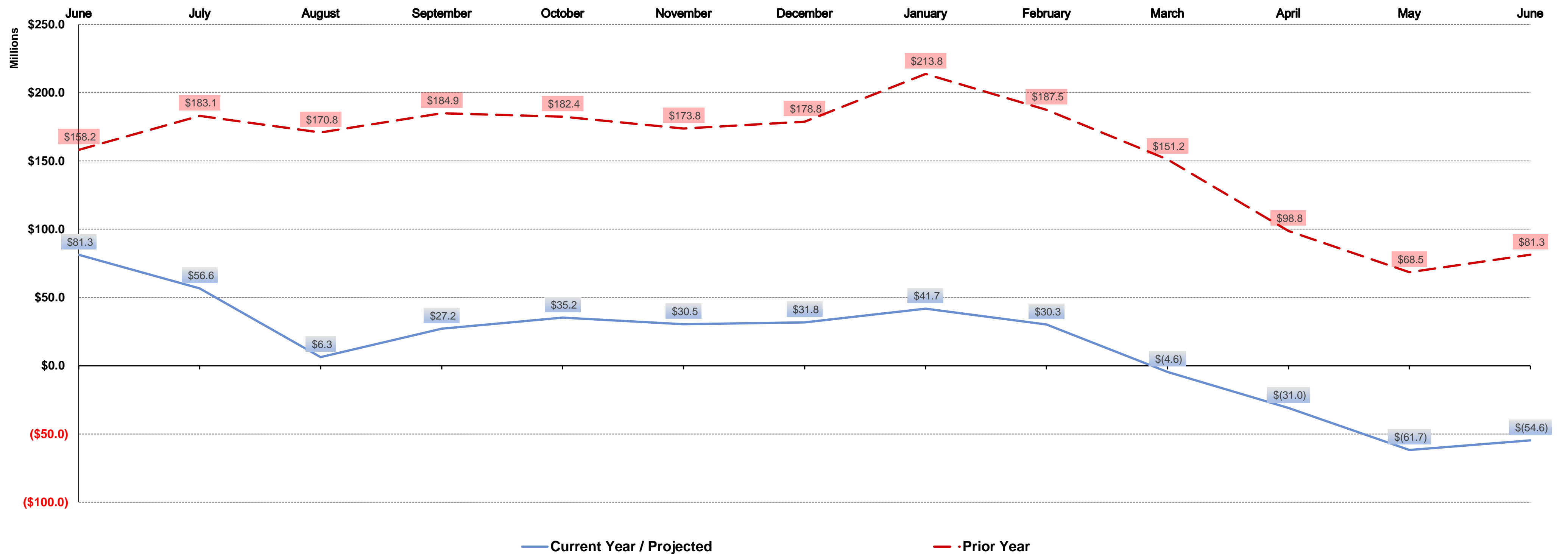

Expenditures by Object

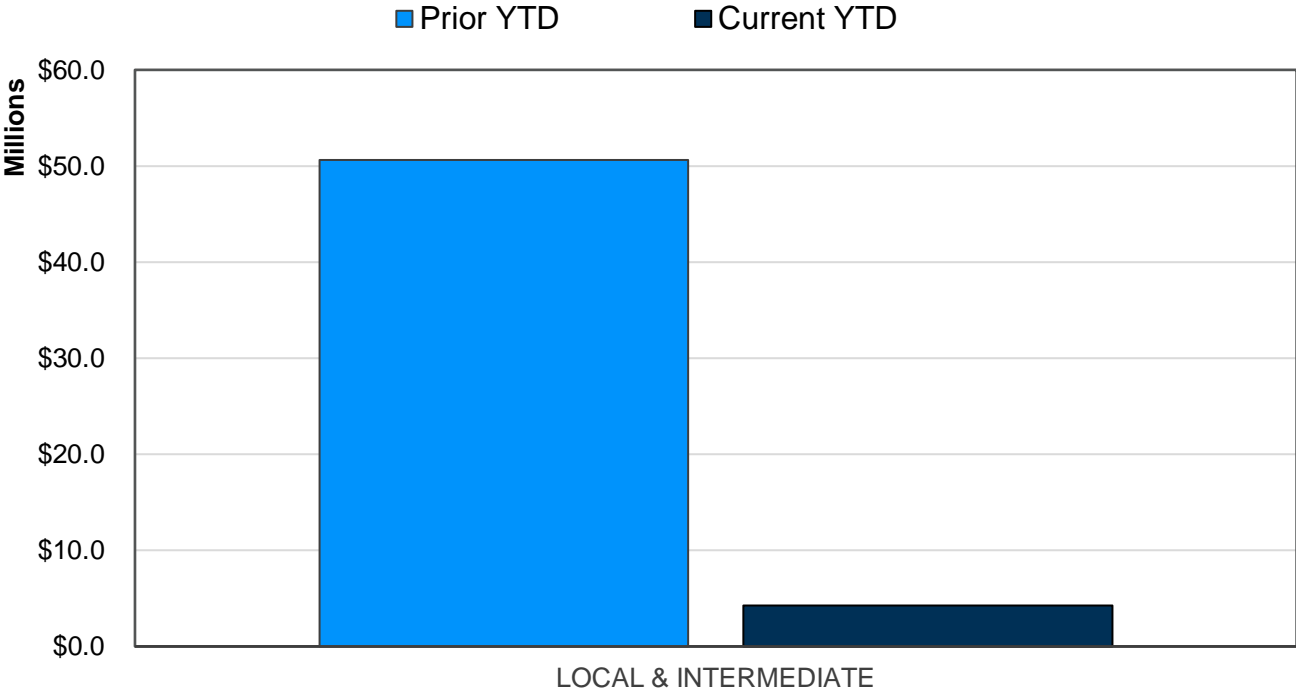

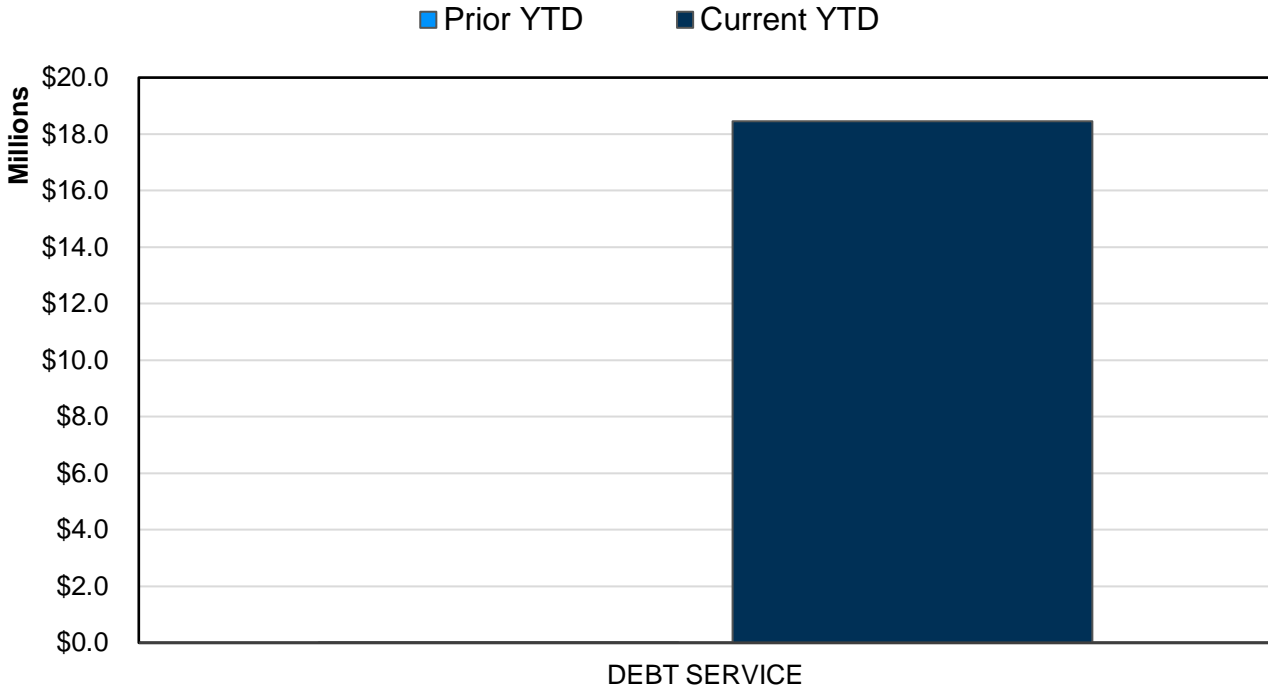

Expenditures by Function



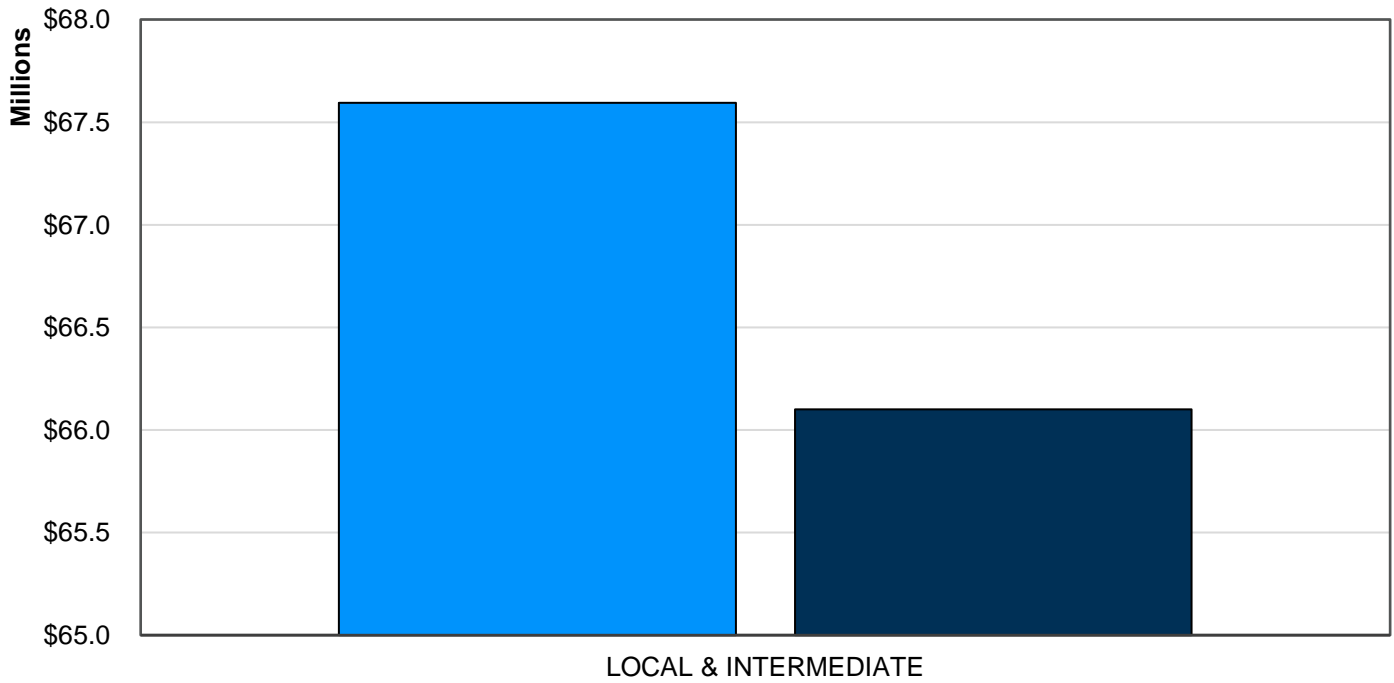

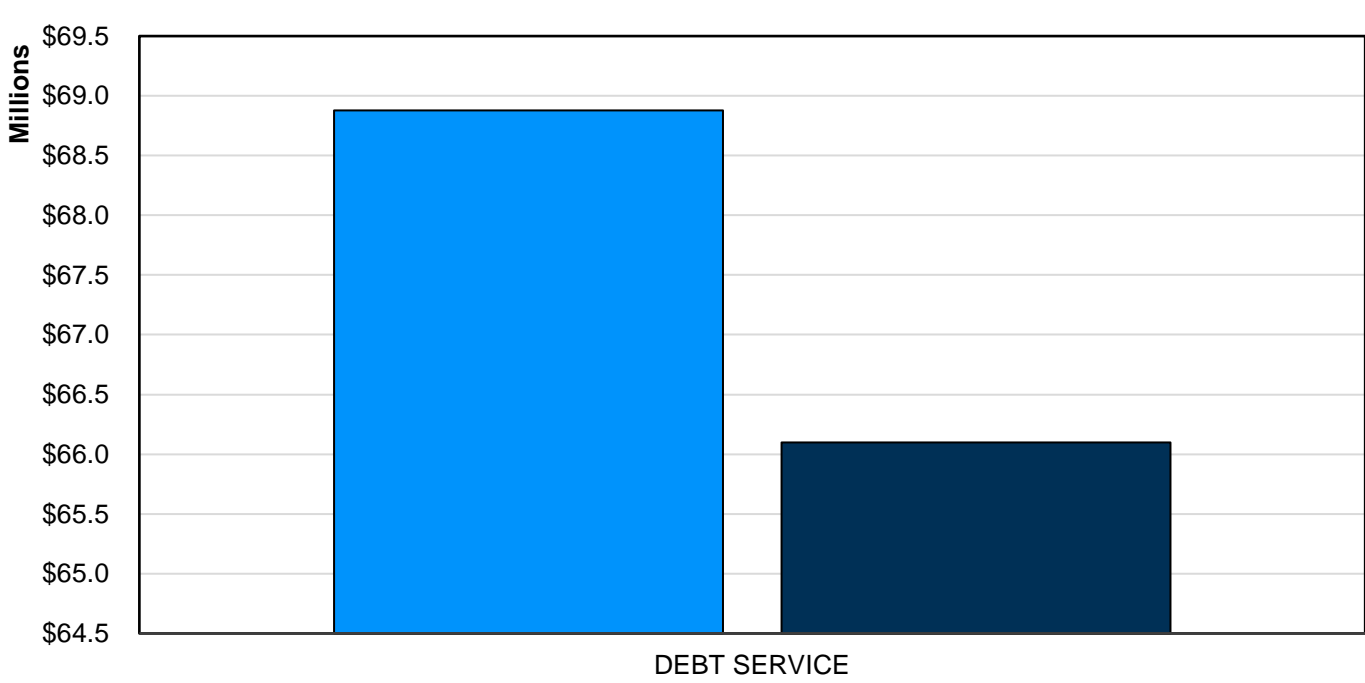
Revenues by Source
