Davis Education Foundation Report:

Davis Education Foundation Grant Writer Ms. Karah Crosby secured a \$19.4 million-dollar USBE Grant to expand the existing Catalyst Campus. The 2026 Heidi Marting Mighty Heart Education of Excellence Award was presented to Ms. Shaunee McFadden who is a Special Education teacher at Knowlton Elementary. This also includes a generous and anonymous donation of \$10,000.00 to support student needs and programing at Knowlton. There were 16 Excellence in Education Awards presented to teachers whose literacy growth scores rank highest in the Davis School District. All Unified Sports promote belonging, leadership, and school unity. Ms. Price expressed appreciation to the Murdock Family Foundation, and the Burton Foundation for their sponsorship in supporting Unified High School and Junior High Basketball and Elementary School Snowshoeing. Mountain High School received a \$20,000.00 donation from Lifeline Inc. in support of their Teen Center. Hogan Construction donated \$5,000.00 for the Best of Davis Employee Recognition.

USBA Report:

Joint Legislative Committee (JLC) for this Legislative Session met and will continue to meet at the Capitol. Ms. Gerrard sent Board members the latest bill tracker that detailed the positions taken by the JLC on Education Bills. The Legislative Session ends on Friday March 6th. There were 1,016 Bills and Resolutions this year. The JLC took a position on 98 Bills. Thank you to everyone that was a part of the process. Caucus Night is Tuesday March 17th. The USBA Board of Directors held a meeting in February. The mission of the USBA is to build better Boards. The three (3) areas of Focus are, Professional Development, Assistance for local Boards and Advocacy for Public Education. The next Region meeting is March 12th at 6:00pm where they will be discussing the Legislative Session and next year's Legislative Priorities.
