CONSENT

Trustee Manish Sethi motioned to approve the following consent agenda items:

Anthony Hill seconded the motion. The motion carried 7-0.

ACTION

Anthony Hill made a motion to approve the resolution adopting the Official Budgets at the fund and function level for the General, Food Service, and Debt Service Funds for fiscal year beginning September 1, 2023, and ending August 31, 2024, as presented and in accordance with Texas Education Code 44.002-44.006. Nichole Bentley seconded the motion. The motion carried 7-0.

Manish Sethi made a motion to adopt the resolution regarding 2023-2024 tax rates as presented by the Board of Trustees. Ranna Raval seconded the motion and the motion passed 7-0.

A motion to approve the resolution of the 2023 Certified Tax Roll as required by the Texas Property Tax Code, Section 26.01 was made by Nichole Bentley and seconded by Anthony Hill. The motion passed unanimously 7-0.

Jobby Mathew motioned that for the 2023-2024 school year, the Coppell ISD Board of Trustees delegate contractual authority to obligate the school district under Texas Education Code (TEC) §11.1511(c)(4) to the superintendent, solely for the purpose of obligating the district under TEC, §48.257 and TEC, Chapter 49, Subchapters A and D, and the rules adopted by the Commissioner of Education as authorized under TEC, 49.006. This included approval of the Agreement for the Purchase of Attendance Credits or the Agreement for the Purchase of Attendance Credit (Netting Chapter 48 Funding). The motion was seconded by Leigh Walker and passed 7-0.

In order to be in compliance with HB 3033, Manish Sethi motioned to approve the Public Information Calendars for the years 2023 and 2024 designating the following dates as nonbusiness days for 2023: October 9, November 20-22, December 19-21, December 27-29 and designating March 14-15, April 12, October 14, November 25-27, December 27, and December 30-31 as nonbusiness days for 2024. The motion was seconded by Nichole Bentley. The Board passed the motion by 7-0.

A motion to approve the Resolution for a Good Cause Exception to House Bill 3 as presented was made by Nichole Bentley and seconded by Anthony Hill. The motion passed unanimously 7-0.

David Caviness made a motion to nominate Manish Sethi to apply for a Texas Association of School Boards (TASB) Advocacy Institute stipend. Anthony Hill seconded the motion and the motion passed 7-0.

Jobby Mathew made a motion to nominate Nichole Bentley as an alternate to apply for a Texas Association of School Boards (TASB) Advocacy Institute stipend. Ranna Raval seconded the motion. The motion carried 7-0.

A motion to endorse Kevin Carbo for TASB Board of Directors Region 10 Seat D was made by Anthony Hill and seconded by Nichole Bentley. The motion passed 7-0.

Nichole Bentley motioned to authorize Dr. Brad Hunt, Coppell ISD Superintendent or his designee, to submit a written complaint to the State Board of Educator Certification with

a finding that good cause did not exist pursuant to section 21.210(c)(2) for Christina Hunter to abandon her employment contract with the District. Anthony Hill seconded the motion and the motion passed 7-0.

A motion to authorize Dr. Brad Hunt, Coppell ISD Superintendent or his designee, to submit a written complaint to the State Board of Educator Certification with a finding that good cause did not exist pursuant to section 21.210(c)(2) for Edith Flores to abandon her employment contract with the District was made by Manish Sethi and seconded by Jobby Mathew. The motion passed 7-0.

Jobby Mathew motioned to authorize Dr. Brad Hunt, Coppell ISD Superintendent or his designee, to submit a written complaint to the State Board of Educator Certification with a finding that good cause did not exist pursuant to section 21.210(c)(2) for Elizabeth Cavender to abandon her employment contract with the District. Ranna Raval seconded the motion and it passed 7-0.
