7.3. Opioid overdoses are an increasing concern across the nation. In response, MSBA collaborated with the Minnesota Department of Health (MDH) to create a model policy to assist schools that may have or are considering overdose medication availability.

New Model Policy 516.5 (Overdose Medication) offers guidance and support for Minnesota schools that choose to obtain, administer, and store Naloxone (Narcan), a medication "designed to help reverse the effects of an opioid overdose in minutes."

No Board action is requested tonight – informational tonight; however, in light of a recommended three-meeting approval process for this type of policy, the Board may wish to begin the review process as early as April.
