Dear Mr. Helppi, Administration and School Board Members,

Bids for the High School & Discovery Elementary Addition and Upgrades were opened on Thursday, December 12, 2024, at 2:00 pm. This was a public opening.

The results of this Bid Package process include the following highlights:

- 25 bid divisions were established for bidding
- Local and regional contractors were directly contacted to inform them of the project and request bids for the project.
- Regional Building Exchanges were provided bid documents.
- 214 contractors expressed interest in bidding on the project.
- 161 separate bids were collected and opened at bid opening.
- 7 Alternates were bid to identify specific costs for additional work.

Please see the attached bid tabulation.

By utilizing a Construction Management bid process, exact costs by bid section have been obtained to verify the true cost of work as specified. We are pleased with the level of local contractor interest and with the quality of the contractors who submitted bids.

The next step in the process is to approve the base bids and alternate contingent upon a successful pre-award interview of the apparent low bid contractors to confirm their bid amount and construction schedule.

Alternate #4 bid: Provide Irwin Seating Citation <u>Low Back</u> Theater Seating as shown on the project drawings in lieu of Hussey Seating Company High Back Theater Seating.

DEDUCT OF \$ (32,691.00) when comparing the base bid price of \$274,800.00 to the provided price of \$242,109.00. The alternate Bidder H2I also provided a voluntary alternate for an Irwin High Back Theater seat in the amount of \$269,490.00. Recommendation to REJECT

Alternate #5: Auditorium House Lights

Base bid: Under the base bid replace existing incandescent lamps in all of the existing auditorium house lights see drawings E022 HS

Alternate #5 bid Under the alternate bid carefully remove the existing auditorium house light fixtures and provide new replacement light fixtures, refer to drawings E122_HS and light fixture schedule on drawing E600_HS
