The above Base Bid recommendations do not include award for the Alternate Bids. The following Alternate Bids are available for incorporation into the project scope of work. Please indicate by initialing whether each portion of the alternate is accepted or rejected. We recommend accepting Alternate 2 bids from Arcorp Structures, LLC, Shales McNutt, Quality Controls Systems Inc. and JB Contracting Corporation. We recommend rejecting the Alternate bid 2 from Elens & Maichin Roofing & Sheet Metal as the contractor misinterpreted the scope. The price for this work will be negotiated at a later date. We recommend accepting Alternate Bid 3 to fusion splice the fiber feed from T&I Building to Pathways Building. If at a later date it is determined that the fusion splice is not needed, this cost would be credited back to Joliet Township High School District #204.
