BACKGROUND

- Modified calendar first implemented in 2001-2002 school year
- Started as a pilot program in the district.
- If increased student achievement was evident, would consider adopting modified calendar across the district.

COMPARISON SCHOOLS

- Compared Maple data to other District schools with similar demographics:
 - Loves Park Elementary
 - Windsor Elementary





STUDENT PERFORMANCE ON ISAT


- Maple houses the CARE program at 4th, 5th, and 6th grades.
- Students are selected for this program if they are one or more grade levels behind academically.
- We looked at achievement data with and without CARE students' results


ISAT ACHIEVEMENT DATA - MATH






ISAT ACHIEVEMENT DATA - READING


The larger number of IDTs out of Maple are due to the modified calendar. Parents often note other children's school schedules and difficulties with daycare as their reasons for wanting the traditional calendar.

STUDENT ATTENDANCE DATA



Over 7 school years, all three schools had attendance rates between approximately 94% and 95.5%.

SURVEY DATA

- 78% of teachers feel the modified calendar positively impacts students' academic success.
- Many teachers feel the frequent breaks help reduce the number of discipline referrals.
- Teachers see the breaks between quarters to be beneficial for both students and teachers to regroup/refresh.
- Parent survey revealed that those who chose not to send their child(ren) to Maple did so because of the calendar.
- 37% of current Maple parents responding stated that they have issues finding daycare during breaks.
- 59% of parents responding feel the modified calendar has positively impacted their child(ren)'s education.

SUMMARY OF FACTORS & RECOMMENDATION

- Lack of data to indicate that student academic achievement, attendance, or discipline referrals are significantly impacted by modified calendar.
- Number of parents requesting a transfer to another District school because of the calendar.
- Professional Development challenges with different calendars.
- Additional costs of calendar.
- Recommendation is that Maple Elementary School calendar will be aligned with other District school calendars beginning with the 2013-2014 school year.
