Treasurer Report: Thompson presented the January 2025 Revenue Expense Report and

Treasurer 's Report. The general fund total as of January 31, 2025, is \$6,798,381.04. The winter tax bills were due February 14th. Real property taxes have been turned over to Genesee County Treasurer's Office as of March 1, 2025. You will need to make all real property delinquent tax

payments there.

**Building Report:** Rizk said we had eight (8) sewer discharges. That means we had at least eight

(8) sales in this municipality. We have two (2) almost completed homes in Pheasant Run and two (2) building permits pulled on a project that has been stalled for 14 years. We have some interest in the condos at Vienna Meadows.

Our housing program is getting better and better.

**Planning Report:** Thompson announced the Planning Commission had their regular meeting on

February 24th. Three (3) rezone requests came before the Planning

Commission for residential family to agriculture. They were for 2304 W. Wilson

Rd., 2160 W. Wilson Rd., and a parcel on Farrand Rd. All three (3) were postponed and will be coming before us again at the end of this month.

**ZBA:** Johnson reported the Zoning Board of Appeals did not have any activity last

month.

**Library Report:** Thompson relayed the Library Board will be meeting this Wednesday at 5:30

PM. We will be discussing changing our fiscal year and need to discuss potential repairs for the building. We have birds that have found their way into

the ceiling above the computer lab and set up home there.

**Senior Center Report:** SThomas announced there was not a meeting due to a snowstorm.

Fire Authority Report: Bryan announced at the last meeting they received the annual report from

last year. The report is on the Fire Department's website. We approved a revision to the harassment policy and to the equal opportunity policy. We added an explorer to the program. We voted on automatic mutual aid for structures with Forrest Township. We have approved our budget for next year.

**BDA Report:** Director Maxwell reported they are partnering with the City of Clio to put on a

Small Business Workshop on March 27<sup>th</sup>. Family Farm and Home are planning their Grand Opening on March 27<sup>th</sup> at noon. The pergola at Bridge Park was

damaged. We are working with a local contractor to determine what

happened. We are not sure if it is vandalism or a construction issue. Asphalt Management is the company we have contracted to put the asphalt down at the Clio Youth Sports Complex. They assure us we are first on the list. The pickleball courts will be open after the parking lot is open and some cosmetic things are completed. The public is welcome to attend our board meetings.

Sports Complex Report: JThomas thanked Marlene Wilson for the donation to the Clio Youth

Sports Complex. We are going to put money into new playground equipment for the kids. At the last meeting, we were discussing a new President and Treasurer for the Sports Complex. The three organizations could not present financial accountability to the board when asked. In the Sports Complex

account, there is \$30,997.95.

**Supervisor Report:** Rizk stated we have had an ongoing problem with our roads recently. In

October we discovered that the chipseal put down on Field Road, Neff Road, Dodge Road, and Elms Road last year had a deficiency. I have met with the Road Commission on several occasions, and they assured me it was not a chipseal problem, it was an asphalt problem. We have made a decision that chipseal would not be welcome in our municipality again. I voiced my opinion at the last Road Commission meeting. This year ditching projects will occur on Lake Road - Clio to Neff, Tuscola Road - 850 feet, Linden Road - East side - half mile. We were looking for solar flashing signs on Linden/Lake and

Farrand/Webster Roads and we were informed by the Road Commission that we do not meet the criteria to receive those signs. Welcome Samantha Merchant to our Building Department. Thank you to Marlene Wilson for her donations to this community. We will be looking at a resolution for Fire Insurance withholding program.
