It is recommended that the Board approve the selection of CGC General Contractors, Inc. to provide the general contractor services for RFCSP 24-10 Judson MS Overlay Asphalt Paving & Drives project in Bond 2016 and that the Board of Trustees delegate the authority to the Superintendent or their designee to execute all contracts and related documents necessary to complete this project. The scope of work is a parking lot renovation including but not limited to the removal and replacement of asphalt pavement, concrete flatwork, signage, striping and all other work as indicated in the contract documents. Expenditures will be made from Bond 2016 funds at a total cost of \$122,000.00.
