#### **REPORTS AND DISCUSSION ITEMS**

### Superintendent's Advisory Team: Finance

The Superintendent's Advisory Finance Team met on November 4, 2025. Board members Charles Zona and Sean Mason, along with Assistant Superintendent for Finance and Operations Griffin Sonntag and Superintendent Dave Palzet, attended the meeting. Charles Zona reported that the team reviewed the five-year financial projections and discussed known and assumed financial factors.

### Proposed Tax Levy

The Board of Education unanimously approved its proposed tax levy for 2025, asking Cook County for a levy of \$16,764,289, with \$13,897,280 allocated to the Education Fund. The District uses historical information and input from the local assessors to produce this request. To ensure transparency with our community, the District will hold a Truth in Taxation Hearing at the December 10, 2025 Board of Education Meeting. The Certificate of Tax Levy will be filed with the Cook County Clerk no later than December 30, 2025.

# ACTION NO. 15 Resolution Approval

Motion by Lenzen, second by Brockob, that the Board of Education approve the proposed 2025 tax levy and authorize the publication of the public hearing. Motion carried by a roll call of 7 ayes (Walters, Mason, Marchione, Zona, Lenzen, Brockob, and Nash).

## Community Engagement

Dr. Palzet provided the Board with an overview of the Community Engagement process scheduled to begin in January. The process will start with the formation of a Facilitation Committee, which will review the Board of Education's priorities and develop opportunities aligned with those priorities. The committee will then design and lead Community Workshops to gather public feedback and refine plans accordingly. A final report from the Facilitation Committee will be presented to the Board at its June meeting.
