School Board Committees

Finance Committee

Staff contact:	Business Manager
Purpose:	This committee reviews budget-to-actual expenditures; budget assumptions, parameters, and levy amounts; financial impact of proposals; leases, major bids, and capital projects; criteria for 5-year financial plan; and audit reports with auditors.
Estimated Time Commitment:	Monthly meetings.
Composition:	3 members (including school board treasurer)

Operations Committee

Staff contact:	Superintendent
Purpose:	The Operations Committee reviews and makes recommendations about buildings and grounds, safety and security, food services, transportation, and technology issues.
Estimated Time Commitment:	Monthly meetings.

Personnel Committee

Staff contact:	Superintendent
Purpose:	The Personnel Committee reviews and makes recommendations about proposed staffing plans and proposals, requests for new positions, and personnel policies. The committee meets and confers with employee groups as needed and hears grievances on behalf of the school board. The committee also negotiates with or recommends the terms and conditions of employment for all employees except teachers, food service workers, custodians, and support personnel.
Estimated Time Commitment:	Monthly meetings except when negotiating with bargaining groups.
Composition:	3 members

Legislative and Policy Committee

Staff contact: Superintendent

Purpose: The Legislative and Policy Committee reviews pending legislation seeks legislative initiatives for the school district including lobbying and attending legislative sessions as needed, reviews and recommends policies and handbooks to the school board, and reviews the implementation of policies.

Estimated Time Commitment: Monthly meetings. Lobbying visit to the state legislature during the session. Significant reading.

Purpose: This committee negotiates with the teacher bargaining group.

District Advisory Committee (also known as the Advisory Committee for Comprehensive Continuous Improvement of Student Achievement)

Purpose:	This community-based committee helps the school district formulate and implement its strategic plan, serves as a communications link with Parent Advisory Councils, and fulfills legal requirements as outlined in Policy 616.
Estimated Time Commitment:	Quarterly meetings.

Contact:	Director of Teaching and Learning
Purpose:	This committee develops action and work plans to support the school district's strategic plan and reviews new course proposals and other curriculum-related issues.
Estimated Time Commitment:	Quarterly meetings held during the school day.

District Technology Committee

Contact:	Director of Buildings, Grounds, and Technology
Purpose:	This committee discusses current technology needs, discusses how the school district can support educational needs with technology, and reviews technology requests.
Estimated Time Commitment:	3-6 meetings per year generally held shortly after the end of the school day.

Calendar Committee

Contact:	Superintendent
Purpose:	This committee develops and makes recommendations about the school calendar and schedules for teachers on flex schedules.
Estimated Time Commitment:	3-6 meetings per year generally held shortly after the end of the school day.

Purpose: This person receives mailings from the Minnesota State High School League.

Estimated Time Commitment: Minimal time commitment.

Community Education Advisory Committee

Contact: Director of Community Education and Recreation

Purpose: This person serves on the Community Education Advisory Committee, which is required by law. The committee is responsible for seeing that Community Education programs serve the interests and concerns of the community and provide input into the overall direction of the Community Education programs and services.

Estimated Time Commitment: 5-6 meetings per year. These meetings are currently scheduled to be held on one Tuesday per month at 11:00 am, but the schedule may change depending on availability of members.

Goodhue County Education District Board

Contact: Director of Special Education

Purpose: This person serves on the board for the Goodhue County Education District, which provides programs and services for the five member school districts.

Estimated Time Commitment: Monthly meetings are currently scheduled to be held on the 4th Thursday of each month except for November and December when a combined meeting is held on the first Thursday in December.

Each member also serves on one or more committees. The time commitment for this work varies depending on the committee.

Other Notes: Currently, each member of the GCED Board receives a stipend for attending board and committee meetings. Mileage at the federal rate is also paid to board members.

Joint Powers Recreation Board

Purpose: The school board appoints two members to serve on the board, which resulted from a joint powers agreement with the City of Red Wing. The purpose is to work with groups or individuals to help facilitate and promote a positive lifestyle among the residents of the Red Wing area.

Estimated Time Commitment: 6 meetings per year currently held at 7:00 am on the third Thursday of selected months, but this schedule may change depending on the availability of its members.
