Approval of the Denton ISD Proposed Legislative Resolutions & Priorities for the TASB 2018-20 Advocacy Agenda

SUMMARY:

The Texas Association of School Boards (TASB) has invited the Denton ISD Board of Trustees to submit resolutions to be included in the 2018-20 Advocacy Agenda.

- In consideration of the TASB Advocacy Agenda efforts, the Denton ISD Board of Trustees approves and submits the following proposed resolutions:
 - Advocate for legislation opposing and/or restricting the diversion of public funds away from Texas Public Schools
 - o Advocate for legislation requiring a comprehensive review of charter school policies, transparency, and charter school expansion.
 - o Advocate for an assessment and accountability system that values student growth and achievement over time, rather than standardized, high-stakes one day testing.
 - o Advocate for legislation making public education funding a priority.
 - Advocate for legislation addressing the mental health needs and school safety of our children.
 - Advocate for full funding for the expansion of <u>universal</u> high-quality Pre-K programs.
 - Advocate for a school finance system to provide adequate and equitable resources for all Texas Public Schools.
 - Advocates for effective governance structures allowing for local control of the school district.
 - o Advocates for increased state funding to assist with the rising health care costs associated with TRS-ActiveCare and TRS-Care.

PREVIOUS BOARD ACTION:

Discussion during workshop agenda of the Denton ISD Board of Trustees' TASB resolutions draft on May 14, 2019 and May 28, 2019.

BACKGROUND INFORMATION:

Resolution proposals will be accepted until 11:59 p.m. on June 17, 2019. Proposed resolutions are first reviewed by the TASB Resolutions Committee and then by the TASB Board. In September, the 2019 Delegate Assembly will adopt approved resolutions that will form part of the 2018-20 Advocacy Agenda, which will remain in effect until the end of the 2020 TASB Delegate Assembly.

SIGNIFICANT ISSUES:

As the District continues to express concern and advocates for policy changes to address the capacity of Texas public education to provide an equitable education for all Texas students, we recognize the need for continued support and advocacy for legislation promoting all Texas
