### **Interlocal Bid Participation Agreement**

## Between Denton ISD and the Region 10 Multi-Region Purchasing Cooperative

December 10, 2019

#### **SUMMARY:**

This item requests approval of the Interlocal Bid Participation Agreement between the Region 10 Multi-Region Purchasing Cooperative and the Denton Independent School District.

#### **BOARD GOAL:**

Growth & Management - Demonstrate effective and efficient management of district resources.

#### PREVIOUS BOARD ACTION:

The Denton ISD Board approved an Interlocal & Bid Participation Agreement with Region 10 Multi-Region on February 26, 2019. The term of the agreement is July,1 2019 through June 30, 2020. This agreement was to obtain pricing quotes.

#### **BACKGROUND INFORMATION:**

Denton ISD has utilized Prospering Pals Cooperative for commodity processing for school year 2019. Prospering Pals commodity processing cooperative is dissolving on June 30, 2020. The District wishes to purchase products and services using Region 10 Multi-Region Bid Participation Agreement as the needs arise.

#### **SIGNIFICANT ISSUES:**

This Interlocal Bid Participation Agreement will allow the District to use contracts executed by July 1, 2020 with vendors that the Region 10 Multi-Region Purchasing Cooperative has in place. This practice would allow for commodity purchases at anticipated cost savings beneficial to the District. Membership in the Region 10 Multi-Region Purchasing Cooperative has no annual membership fee. The Interlocal Bid Participation Agreement requires annual renewal. The agreement is a single-term agreement effective July 1, 2020 through June 30, 2021.

#### FISCAL IMPLICATIONS:

Purchases will be made through the appropriate departmental budgets. Vendor participation fee collected from vendors for operation of the cooperative.

#### **BENEFIT OF ACTION:**

The District is in compliance with bid laws and Board Policy CH (Local), which further the policies and purpose of Local Government Code, Chapters 271 and 791.

#### **ALTERNATIVES:**

The alternative would be for the District to seek agreement with other commodity processors within the state.

#### SUPERINTENDENT'S RECOMMENDATION:

It is recommended that the Interlocal Bid Participation Agreement between the Region 10 Multi-Region Purchasing Cooperative and the Denton Independent School District be approved for the purchase of commodities for the term effective July1, 2020 through June 30, 2021.
