BOARD OF MANAGERS RESOLUTION SEPTEMBER 9, 2015

A RESOLUTION AMENDING LISTING OF INDEPENDENT SOURCES OF APPROVED INVESTMENT OFFICER TRAINING

WHEREAS, the Nueces County Hospital District (the "Hospital District" or "District") is a body politic and corporate and a political subdivision of the State of Texas, established and created pursuant to the Texas Constitution, Article IX, Section 4 and the Texas Health and Safety Code (the "Health Code" or "Code"), Chapter 281, and operated in accordance with the Health Code and other applicable laws of the State of Texas, including the Texas Government Code (the "Government Code"), Chapter 2256;

WHEREAS, the Board of Managers of the Hospital District (the "Board") is the governing body of the Hospital District, pursuant to Health Code, §281.048, and pursuant to the collective authorities of the Health Code, §281.047 and §281.048, the Board has, and at the time of adoption of this Resolution had, full power and authority to manage, control, administer, and to adopt rules governing operation of the District;

WHEREAS, the "Public Funds Investment Act" at Government Code, §2256.008(a)(2) (the "Act") requires that the governing body of the Hospital District approve independent sponsors that may be used by the District to provide investment training to District employees who are required to attend such training under the Act;

WHEREAS, the Board, at prior meetings held on September 8, 1998, August 8, 2000, and December 16, 2003 reaffirmed, additionally approved, and/or removed investment training sponsors pursuant to its authority under the Act and adopted then a replacement approved training sponsor listing, and the current replacement approved training sponsor listing was adopted on December 16, 2003 (the "Current Approved Training Source List"); and

WHEREAS, the Board now desires to amend the Current Approved Training Source List to: (1) add additional face-to-face investment training sponsors, (2) add Internet-based investment training sponsors, and (3) remove an existing investment training sponsor.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MANAGERS OF THE NUECES COUNTY HOSPITAL DISTRICT, THAT:

- 1. The Board hereby amends the Current Approved Training Source List by adding the following additionally-approved face-to-face investment training sponsors: (i) Education Service Center, Region 2, (ii) Tax Assessor-Collectors Association of Texas, (iii) Texas Association of Appraisal Districts, (iv) Texas Association of Assessing Officers, (v) Texas Association of School Administrators, (vi) Texas Housing Association, (vii) TexPool, and (viii) Texas Rural Water Association to the Training Source List.
- 2. The Board hereby amends the Current Approved Training Source List by adding the following approved Internet-based investment training sponsors: (i) Virtual Learning Concepts by Patterson & Associates and (ii) William P. Hobby Center for Public Service at Texas State University to the Training Source List.
- 3. The Board hereby amends the Current Approved Training Source List by removing the following existing training sponsor "Texas Higher Education Coordinating Board" from the Current Approved Training Source List.
- 4. The Board hereby reaffirms its prior approval of the non-removed investment training sponsors shown on the Current Approved Training Source List.
- 5. The Board hereby adopts a replacement approved training sponsor listing to replace the Current Approved Training Source List to include the above-resolved and the replacement approved training sponsor listing is attached hereto and identified as Attachment "A" to be effective as of September 10, 2015.
- 6. Upon adoption, this Resolution shall supersede and replace any and all previous Board actions relating to the approval of independent sponsors that may be used to provide investment training to District employees who are required to attend said training under the Act.
- 7. The Administrator, in his capacity as the Secretary of the Hospital District Board, be and is hereby legally authorized and empowered to certify these resolutions and that the provisions hereof are in conformance with the laws of the State of Texas and the Governing Board Bylaws of the Hospital District.
- 8. This Resolution shall take effect and be in full force and effect upon and after its passage.
