ZIER PROJECT UPDATE MEETING

• Due the information that was out in regarding Brackett ISD receiving 11.7 million dollars from the ZIER Solar projects, we began an investigation regarding how that number was being calculated.

Findings:

1 – Currently, Brackett ISD is in a chapter 313 agreement with ZIER. The district projections regarding revenue from ZIER was a payment of \$54,000 for 20 years

2 – The agreement was entered into in 2019 with the understanding of little or no impact to the school district unless I&S debt was issued.

Due to a number of questions and concerns a meeting was scheduled with ZIER Project managements

1 – Tax abatement agreement – 2000 acres of solar panels

2 – ZIER calculated based on life time of project for 40 years; comptroller calculations is only for 20


3 – Calculations were done based on incorrect tax rate – when the agreement was passed the tax rate was over .80cents and now it is .66cents

4 - ZIER management mentions "revenue protection" payment but that amount is only estimated

5 – Overall comments from ZIER – "apologize for the misreporting and for the unfortunate error"

5 – Corrective statement from ZIER will be issued to the district; on 09/03 follow up email sent; response was they are redoing calculations and will have something before the end of the week.
