



APPROVAL OF BOND COMMITTEE MEMBERS

POLICY ISSUE/SITUATION

Three of the current Beaverton School District Capital Construction Bond Citizen Accountability Committee (BAC) members, having served for two years, have retired from the Committee. The School Board should appoint replacements.

BACKGROUND INFORMATION

School Board Resolution 16-693 approved on July 11, 2016 modified the BAC Charter changing membership from seven members to between seven and nine members. With three members leaving the Committee the Board may select between three and five new members. The new Charter also specifies that members are to be appointed to three-year terms ending on June 30 of the applicable year.

The School District posted an announcement seeking applicants for the BAC on the BSD webpage and via a press release. Several applications were received and reviewed. Four individuals are being recommended for appointment to the BAC; their applications materials are attached.

Appointing individuals to vacant positions at this time will allow the BAC to be fully constituted for its next scheduled meeting on September 19, 2016.

RECOMMENDATION

The Beaverton School District Board of Directors hereby appoint these individuals to three-year terms on the Beaverton School District Capital Construction Bond Citizen Accountability Committee: Raymond Hoover, Renu Kamath, Karl S. Schulz, and Tina Smith, with terms ending June 30, 2019.

After graduation from Lewis and Clark College in 1957 with a degree in Business Administration I was employed by a local CPA firm for approximately 10 years. During which time I obtained my CPA Certificate.

In the late 1960's into the late 1970's I was employed by Orbanco as director of internal auditing. After leaving Orbanco I along with three of my business acquaintances formed a real estate investment and residential construction company, Evergreen Properties, Inc. This company was successful for a while but could not survive the financial crisis of 1980.

I then went to work for NIKE in their internal audit department. When NIKE began construction of its World Headquarters, I was asked to assume the role of construction financial manager. My duties included preparation of monthly financial reports comparing budgeted to actual expenditures, working with architects, project managers, and general contractors to control costs, reviewing change orders for their financial impact on the project etc.

After completion of the first few phases of development, NIKE declared a moratorium on construction projects and I left NIKE and found employment with an accounts payable recovery firm, PRS, Inc. 


