A. Steve Greif - North Bend School Foundation - Steve Greif shared that the North Bend School Foundation recently awarded grants to several teachers for projects and classroom resources they requested. The Foundation helps support educational programs in the district by providing funding that isn't covered by the school budget. C. Student Representatives to the Board

i. High School Representatives — Student representative Grace Clark updated the board on recent happenings at the high school. She shared that fall sports are still in full swing, keeping school spirit high. The leadership team is actively planning new activities to engage students and build a stronger sense of community. Grace also expressed the students' appreciation for the opportunity to earn college credits through their participation in programs offered by the local community college.

D. Association Reports

i. North Bend Education Association Report - Eva Varga addressed the Board. She said it has been a rough start to the year with staff in different positions. K-2 has noticed an impact with a

loss of the music program. NBMS had their open house September 30, Hillcrest had theirs on October 2, and North Bay has theirs scheduled for October 9.

E. Superintendent Report – Superintendent Tim Crider provided an update to the Board, highlighting recent and upcoming events throughout the district. He shared that September was recognized as Suicide Awareness Month, and the district also observed National School Lunch Week. In addition, open houses were held at the middle school, Hillcrest Elementary, and North Bay Elementary, with strong attendance and community participation.

Looking ahead to October, several events are scheduled. The Miss Flame event will take place on October 10. On October 11, a Wayfinder event will be held at North Bend High School; families are encouraged to attend, and lunch will be provided. Homecoming is scheduled for October 24, and Senior Night, along with the car giveaway, will take place on October 31.

Superintendent Crider also congratulated Christina Geierman, who has been named the recipient of the OSTA Outstanding High School Classroom Teacher Award. He further informed the Board that the North Bend School District is participating in a statewide facility assessment program, which will assist with long-term planning for district facilities.
