WHEREAS, this Board of Trustees of said District (the "Issuer") adopted an Order Calling a Bond Election on February 27, 2006 (the "Original Order"); and

WHEREAS, it is deemed appropriate to amend said order to reflect changes in polling places; and

WHEREAS, it is hereby officially found and determined that said meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF COPPELL INDEPENDENT SCHOOL DISTRICT:

1. The Board of Trustees of the Issuer hereby incorporates the recitals set forth in the preamble hereto as if set forth in full at this place and further finds and determines that said recitals are true and correct.

2. The Original Order is hereby amended in its entirety to read as follows:

WHEREAS, this Board of Trustees deems it advisable to call the election hereinafter ordered; and

WHEREAS, it is hereby officially found and determined that said meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF COPPELL INDEPENDENT SCHOOL DISTRICT:

1. That an election shall be held between the hours of 7:00 A.M. and 7:00 P.M. on May 13, 2006, in said District at the following polling places designated by the Dallas County Election Division:

4. That an early ballot board is hereby created to process early voting results, and the individual designated by the Dallas County Election Division is hereby appointed the presiding judge of said board. The presiding judge shall appoint at least two other members of the board.

5. That all resident, qualified electors of said District shall be entitled to vote at said election.

6. That a substantial copy of this Order shall serve as proper Notice of said election, and the President of the Board of Trustees shall cause said Notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date set for the election, in a newspaper published in said District or, if none is published in said District, in a newspaper of general circulation in said District. In addition, not later than the 21st day prior to the date set for the election, the President of the Board of Trustees shall cause said Notice to be posted on the bulletin board used for posting notices of meetings of the Board of Trustees.

7. That at said election votes may be cast for candidates seeking Board of Trustee positions **Place 6** and **Place 7**.

8. That the official ballots for said election shall be prepared in accordance with the Texas Election Code with the ballots to contain such provisions, markings and language as required by law.

9. That in all respects said election shall be conducted in accordance with the Texas Election Code."

3. Except as amended by this Order, the Original Order shall remain in full force and effect.
