- 5. That all resident, qualified electors of said District shall be entitled to vote at said election.
- 6. That a substantial copy of this Order shall serve as proper Notice of said election, and the President of the Board of Trustees shall cause said Notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date set for the election, in a newspaper published in said District or, if none is published in said District, in a newspaper of general circulation in said District. In addition, not later than the 21st day prior to the date set for the election, the President of the Board of Trustees shall cause said Notice to be posted on the bulletin board used for posting notices of meetings of the Board of Trustees.
- 7. That at said election votes may be cast for candidates seeking Board of Trustee positions **Place 6** and **Place 7**.
- 8. That the official ballots for said election shall be prepared in accordance with the Texas Election Code with the ballots to contain such provisions, markings and language as required by law.
