Budget Committee Chair Brett Baker welcomed all to the meeting and called the meeting to order at 6:32 pm.

WELCOME AND OPENING REMARKS

Superintendent Colonna welcomed all to the meeting and spoke to the following topics:

• Kaiser Permanente and BSD will partner to provide free healthcare coverage to 300 needy students in the district.

- Nike pledged to support the District at the same level as this year. Pledging \$600,000 even though they are in the process of laying off 500 employees.
- The District is working hard and positively with BEA and is having productive negotiation sessions.

INTRODUCTORY COMMENTS

• BSD will not be forced to participate in the OEBB insurance plan in the next year.

Superintendent Colonna reviewed the Joint Ways & Means Co-Chairs' Budget Proposal handout.

At the projection levels, the District would receive 48.33% in the first year and 51.7% in the second year of the biennium. This scenario would reduce \$2 million from the District budget in the first year of the biennium.

Superintendent Colonna spoke to why he believes the 6.0 billion level is so important to the District:

- The legislators with whom the District has been working (Senators Mark Haas, Susan Bonamicci, and Representatives Jeff Barker and Tobias Reed) have been working hard to bring the state budget levels to the \$6.0 billion funding level.
- If the state funds at \$6.0 billiion, it would increase the District's ending fund balance by \$1.6 million, which would allow us to bring the ending fund balance in compliance with Board Policy.
- Funding at the \$6.0 billion level would help the District minimize staffing reductions.

Hanna Vaandering – Beaverton Education Association (BEA) President – spoke to the following:

- Membership is sharing negative perceptions about the BEA leadership.
- BEA is dedicated to providing quality education, balanced curriculum, preserving jobs and to protecting the collective bargaining agreement between the District and BEA.
- Staffing ratios and what it will look like in the schools.

John Burns, parent, presented information about his interpretation of the District's current budget situation.

Karen Murphy - advocated for the Spanish two-way immersion in the District.

Parent Bonnie Modus asked the committee what can be done to keep programs going at the schools - what can parents do to support the schools?

Sunset High School staff member, Monica Jankow, advocated for the journalism survey class at her School.

Superintendent Colonna referenced an enrollment projections handout and noted that the current budget situation will require the District to reduce staff by 22 staff members throughout the District.

Parent Heather Leeson advocated for the Spanish two-way immersion programs in the District.

Georgina Vargas, parent, advocated for the Spanish two-way immersion programs at Vose Elementary. She represents the pre-k parents at her school.

The minutes from the May 12, 2009 meeting were approved with no changes.

APPROVAL OF MINUTES

PUBLIC COMMENTS

Superintendent Colonna reviewed the Joint Ways and Means Co-Chairs' Budget Proposal.

JOINT WAYS AND MEANS CO-CHAIRS' BUDGET PROPOSAL

Chief Financial Officer Claire Hertz reviewed the Beaverton School District State School Fund Revenue Adjustment handout.

• Hertz highlighted an adjustment to the General Fund Budget in the amount of \$1,385,000.

ZERO-BASED BUDGETING

Hertz presented information about the possibility of implementing a zero-based budgeting program for the 2010-11 budget process.

The Committee asked the following clarifying questions, to which staff provided answers.

- Would the money reserved for the zero based budgeting be better spent on a budget audit?
- What types of budgeting processes are we considering?

Hertz reviewed the most recent General Fund Budget Adjustments for 2009-10, the Reconciliation from Proposed Budget to Recommended Approved Budget and the Adjustments to the 2009-10 Proposed Budget Document.

CHANGES FROM PROPOSED TO APPROVED BUDGET

Hertz presented information about the changes from the proposed budget to the budget being brought forth for approval.

The Committee asked the following clarifying questions, to which staff provided answers.

- What is the special purpose fund?
- Will the \$400,000 increase in Capital Center be offset by having positions elsewhere?
- Where did the Federal Stimulus Funding go?
- Have the instructional coaches been eliminated from the budget?
- Why has the employee attrition amount dropped by \$1,000,000?
- What accounts for the reduction in the School Non-salary reduction amounts?
- Are there recommendations for TAG spending in the budget?
- What are the 8 administrator positions being reduced?
- Are grant funded positions going to go away after the grant monies go away?
- Will the grant funded positions be temporary positions?
- If approved, how will the open ended budget be administered?
- Where did the change in reducing extended contract days come from?
- What happens to two-way immersion teachers in reductions?
- How do legal staffing issues affect our two-way immersion programs?
- Are the grant positions being filled internally?
- How will staff development take place when funding for substitutes and development time has been reduced or frozen?
- Will teachers be required to give up plan time to receive staff development instruction?
- What will the support for technology look like next year?

Baker led the discussion about the budget document. Cheri McDevitt moved to approve the 2009-10 budget and tax rates as presented to the committee. The motion was seconded by Dave Bouchard. The motion passed unanimously.
