Any such rate reduction shall bear a proportionate reduction to that required of VocoVision by its Client. Either party shall have the right to terminate this Agreement with thirty (30) days advance written notice if the rate reduction is unacceptable.
- Clinician shall notify VocoVision prior to a permanent or temporary relocation or making arrangements to travel during the Contracted Period should the Clinician desire to continue providing services in the new location or during the time of travel as additional licensing and/or work visa may be required.
