



The parties acknowledge and agree that the Start Date and End Date are stated for administrative convenience and are not intended to, and do not, provide for a stated duration of the contract period. Unless otherwise notified, when the end date set forth above has elapsed, this Statement of Work shall be deemed to have been extended beyond the original end date on a month-to-month basis, on the same terms and conditions stated herein and in the Independent Contractor Agreement, until such time as the above-mentioned project is completed or Contractor provides 30 days prior written notice of a refusal to extend this Statement of Work.
- Contractor will submit all time records and Client billing information to VocoVision by Monday 5:00 p.m. EST following the week of services rendered. Documentation received after this deadline may delay payments to Contractor by up to ten (10) days.
- Contractor agrees to complete the assignment within the guidelines as provided by the Client and within the terms of this agreement.
- Contractor's rate is a confidential matter between Contractor and VocoVision and shall not be divulged to any other party, including the Client, unless required by applicable law.
- The rates above are subject to change, at VocoVision's discretion, if the Client for which Contractor is providing services reduces the rate it will pay VocoVision for such services. Any such rate reduction shall bear a proportionate reduction to that required of VocoVision by its Client. Either party shall have the right to terminate this Agreement with thirty (30) days advance written notice if the rate reduction is unacceptable.
- Clinician shall notify VocoVision prior to a permanent or temporary relocation or making arrangements to travel during the Contracted Period should the Clinician desire to continue providing services in the new location or during the time of travel as additional licensing and/or work visa may be required.
