Good morning, I'm not at my court office or I would have emailed from the county's email, but I did cc myself and Janelle Mott. The Juvenile Division, through myself, is requesting the ability to seek a Community Impact Grant from the Community Foundation of NE Michigan. I've been in contact with Kara LeMonds and she asked that I seek permission from both Kim and Mary Catherine in order to apply using the County's tax id. I would prefer if you gave both me and Janelle general permission to apply for grants on behalf of the Juvenile division for this grant request and for future applications. For this cycle, due 7/15, I would like to apply for a \$5000 grant to bring in Nicole Snell to present on a self-defense, anti-violence presentation. She has 2 different presentations that interest me: Girls Fight Back! and Students Fight Back!

The quote from her manager for the program is:

*She can do two separate sessions at a discount. For in-person, we could do it for about \$4850 all-inclusive as long as they're same day. If on consecutive dates, it'll be closer to \$5050.*

*And then the two sessions virtually would be \$3500 all-inclusive, whether they're on the same day or not.*

*If you were asking about splitting the time up between the groups, we can't really condense the content that much, and so we advise against it. The fee would remain the same too, so you might as well go for two full sessions if at all possible with your timing.*

These two sessions would be targeted at junior high ages (12-14) and high school/next level ages (15-18).

I think the juveniles would connect with her and our juvenile delinquency cases continue to rise in the level of violence, threats at school, bullying, etc.

Also, for the future, the Juvenile Division has a special program called PIVOT. For the summer, we like to keep it going as it helps the at-risk kids to go to a safe place during the summer and gives them a chance to earn school credits. Unfortunately, transportation costs are very difficult for us. We may consider applying for a grant for this in the next cycle. So, I would like general permission to submit periodic requests for grants, but if that's not possible, approval to submit this grant would be greatly appreciated.
