Public Hearing on Borman Elementary **Targeted Improvement** Plan

President Barbara Burns opened the Public Hearing at 6:18 pm.

Dr. Daniel Lopez, Area Superintendent presented the process the Borman Campus went through.

In 2015-2016, 52% of Borman Elementary ELL students failed the STAAR in all subjects. Borman's strategy is to develop a campus system to implement the District Bilingual Model in all grade levels. 38% of Borman students failed the STAAR in the area of mathematics. The annual goal will be 75% of all students will pass the mathematics portion of the STAAR. Borman developed and implemented an effective campus system to ensure differentiated instruction in mathematics.

45% of Borman students failed to meet minimum standard on the reading portion of the STAAR. and to also develop a model of effective PLC's that Analyzes the TEKS and student data as a means for designing lessons.

As a result of meeting the established annual goals through the TIP, Frank Borman Elementary will be removed from monitor status know as Formerly Improvement Required (FIR) and the Texas Accountability Intervention System (TAIS) for the 2017-2018 school year.
