

Employment: Personnel Resignations and Recommendations Re-issuing Support Staff Memoranda of Employment 2022

Background:

Under Iowa Code 279.12, the school board has the authority to employ teachers, other licensed professional personnel, and support personnel, and determine their salaries.

Each year the Board of Directors is asked to re-issue memoranda of employment to all support personnel employed by the district. Collective contract bargaining was conducted with the Belmond-Klemme Educational Services Association (BKESA) *this year* resulting in a two-year agreement.

Recommended Action:

I recommend the board issue *Memoranda of Employment* to the current employees listed below for the 2022 – 2023 school year with wages and terms of employment as stipulated by the master agreement negotiated for next year.
