TEA MONITOR REMARKS/REPORT

Dr. Abe Saavedra, TEA Monitor stated: I just want to commend the Board for meeting today. I think it's very timely in light of what happened in Uvalde that the Board review

the safety protocols and amend or change or improve or whatever y'all need to do in reference to that. Mrs. Prado will remember this, that after Sandy Hook, the Board at the time, took some very concrete steps and were criticized for it as a matter of fact, for overacting if I recall correctly Mrs. Prado. In light of what's happened since then, I don't think any kind of action that you take is overreacting to the danger that exists out there. So I want to commend you as a Board, addressing this, and looking at this seriously and make the decisions you might need to make. Thank you.
