

OSAA League Reclassification Update

When we met last month in April, the OSAA had tentatively reclassified Sheridan School District from the 3A West Valley League to the 2A Tri-River Conference.

3A–West Valley League 340 – 191 students	2A–Tri-River Conference 190 - 97 students

Since then the OSAA has met and again updated the following changes to the West Valley League and the Tri-River Conference. The new proposal now reads:

3A–West Valley League 340 – 191 students	2A–Tri-River Conference 190 - 90 students

***It is my understanding that Willamina is petitioning to move to the 2A level.**

During the Parent-Teacher Conferences, Sheridan High School conducted a survey to ask the parents, students, coaches and community members how they felt about the reclassification. The questions asked and the results are as follows:

We would like to know if you believe Sheridan School District should: (Please circle one.)

- A. Stay with the OSAA decision to move us to Tri-River League, and play with schools of comparable size. (62 people, 59.6%, voted yes to choice A) SHS-52/FCS-10**
- B. Petition to stay with *West Valley* 3A league. I understand we would play against larger schools. (39 people, 37.5%, voted yes to choice B) SHS-22/FCS-17**
- C. I do not feel I have enough information to make an informed decision. (3 people, 2.9%, voted yes to choice C) SHS-2/FCS-1**

After talking with the Head Coaches at Sheridan High School, including the Choir and Music Director, the major majority though they like the West Valley League, would see the value of competing with 2A schools.

SUBJECT: Update on the Proceedings of the Classification and Districting Committee

The Classification and Districting Committee for the 2014-2018 four-year time block met at the OSAA office in Wilsonville on April 30, 2013 in a closed work session.

The Committee reviewed and discussed more than 40 pieces of written correspondence received since the last meeting in early April. The goal of this closed work session was for Committee members to spend several hours reviewing correspondence and recommendations.

Following a four-hour work session, the Committee has reached consensus on the following issues.

Number of Classifications: Committee members have maintained consensus to recommend a six classification system.

Adjusted ADM Figures: The Committee instructed the OSAA Staff to send out a survey of member schools during May regarding home school, private school, and associate member school students who participated at their resident public or private school during the 2012-13 school year. The survey will also request information from public schools regarding how many of their students are paying out of district tuition as this information isn't currently reported through ODE. The Committee also asked OSAA Staff to include information regarding the proper procedure and forms to be used by private schools when submitting free and reduced lunch numbers for the 2012-13 school year in the annual request for ADM figures sent to private schools.

Petitions to Play Down: Committee members received their first Petition to Play Down request from a member school. **Schools that are interested in playing outside of their assigned classification through a Petition to Play Down must submit their information to the OSAA by June 1 in order to receive consideration.**

Schools Playing Outside Assigned Classification: The Committee was also formally notified of a school's intent to play up a classification. **Schools that are interested in playing outside of their assigned classification by choosing to play up a classification must submit their request to the OSAA by June 1 in order to receive consideration.**

Geographic Exceptions: Committee members discussed the concept of geographic exceptions and the limited application of these types of exceptions over the years. The Committee understands that this type of exception shall be limited in scope and, as with other recommendations, must ultimately be approved by the Executive Board.

Based on discussion and correspondence received, including enrollment projections from many schools around cutoff points, the Committee made the following changes to Draft #6:

1A: The Committee discussed the 1A/2A cutoff limit at length and believes there is sufficient support from a segment of 1A schools to drop the number to 90. The Committee considered leaving the cutoff point unchanged or lowering it even further but decided that setting the cutoff at 90 brings about a necessary

change that doesn't move too many schools. The Committee is especially interested in hearing from the Old Oregon (5) and High Desert (12) leagues about their thoughts on balancing these two leagues more equitably.

2A: The Committee added a seventh league at the 2A classification and moved several schools in an attempt to more effectively address travel concerns. Based on positive feedback received, the Committee continued to have two leagues in northeast Oregon and one league on the coast. As with Draft #6, Draft #7 has significant travel in some areas but continues to attempt to spread the burden more equitably.

3A: The Committee went with a five league alignment at this classification and moved several schools around in order to balance leagues more effectively and address travel concerns. Committee members spent time discussing the proposed North Valley League (all private schools) and ultimately decided that while concerns about private/public competitive balance are a reality, putting together leagues based on travel and geography outweighs competitive balance concerns.

4A: Cutoff points were changed at both ends in the 4A classification. Four leagues saw at least one school leave or be added with the goal of maintaining six schools per league wherever possible.

5A: The Committee adjusted the cutoff points at both ends of the 5A classification as well. In the end, the classification maintained the same number of schools (39).

6A: Committee members spent considerable time reviewing a proposal from the Metro Area Coordinating Committee for league alignments, specifically those north of Salem. The Committee is proposing alignments similar to this proposal with one exception. Additionally the low end cutoff point was adjusted with the effect of moving one school up from 5A. Committee members believe that having eight teams in the Southern Oregon Conference at 6A is more critical than having eight teams in that region at 5A since 6A schools often have a more difficult time scheduling teams from other classifications.

The Committee is seeking feedback from member schools and encourages your participation in this process.

Written suggestions and proposals on any classification related subjects should be mailed or emailed to the OSAA (kyles@osaa.org) Proposals should use adjusted ADM figures. Any communication received by the OSAA will be shared with all committee members for review and discussion.

The next public meeting of the Classification and Districting Committee will be at 9am on Monday, May 20, 2013, at the OSAA office in Wilsonville. The general format for the meeting will be for the committee to receive public testimony followed by a closed work session.

The Committee will meet once more this school year and will make its final recommendations to the OSAA Executive Board at the October, 2013, Special Classification and Districting Meeting.

SUBJECT: Update on the Proceedings of the Classification and Districting Committee

The Classification and Districting Committee for the 2014-2018 four-year time block met following the OSAA Delegate Assembly meeting on April 8 at the Holiday Inn Wilsonville to receive testimony and review written communication thus far received.

The audience initially received a review of the Classification and Districting timeline and charge from Executive Director Tom Welter. The Committee then received testimony by 14 different people representing 12 member schools.

Following public testimony, the Committee adjourned to a closed work session to review and discuss the testimony and more than 60 pieces of written correspondence it had received since the last meeting in March.

Due to the length of public testimony and a desire on the part of Committee members to spend more time than was available discussing testimony and written correspondence, the Committee decided to schedule an additional closed meeting for Tuesday, April 30 at the OSAA office in Wilsonville. The goal of this closed work session will be for Committee members to spend several hours reviewing correspondence and recommendations. An added advantage of this timeline is the ability for the Committee to receive classification specific feedback from the Oregon Athletic Directors Association (OADA) Conference being held April 14-16 prior to releasing a new draft proposal.

Number of Classifications: Committee members have maintained consensus to recommend a six classification system.

Adjusted ADM Figures: The OSAA Delegate Assembly passed an amendment on April 8 to use Adjusted ADM figures to include an SES factor (25% adjustment based on free and reduced lunch figures provided by the Oregon Department of Education) for schools and the addition of home school, private school, and associate member school students who participate at their resident public or private school. (see attached)

Petition to Play Down: The OSAA Delegate Assembly passed an amendment on April 8 to change the Petition to Play Down. Specifically, this change factors in a free and reduced lunch percentage combined with final RPI ranking and winning percentages over the last couple of years in team sports to help determine if a school should be moved down from its assigned classification. (see attached)

Schools Playing Outside Assigned Classification: Schools that are interested in playing outside of their assigned classification (either petitioning to play down or choosing to play up) must submit their information to the OSAA by June 1 in order to receive consideration.

The Committee is seeking feedback from member schools and encourages your participation in this process. **Written suggestions and proposals on any classification related subjects should be mailed or emailed to the OSAA (kyles@osaa.org)** Proposals should use adjusted ADM figures. Any communication received by the OSAA will be shared with all committee members for review and discussion.

Proposal to Amend Article 6.3 “Classification of Schools – Computation of ADM”

(Action Item)

QUESTION: *Should the Delegate Assembly amend Article 6.3 “Classification of Schools – Computation of ADM” to change how the OSAA computes an ADM figure for each full member school?*

RATIONALE: The OSAA has calculated a school’s ADM figure the same way for nearly its entire 95 year history. Educational opportunities available to students have changed dramatically in the past 15 years with the spread of home schools, charter schools and online/virtual schools. Member schools have students that aren’t attending the school but are representing them in OSAA sanctioned activities. Currently, these students aren’t being counted in the school’s ADM. Additionally, many schools with a significant number of students on free and reduced lunch have experienced a limited amount of success throughout their programs. Factors may include that some students from lower incomes have limited access to club programs, out of season camps, training opportunities, and perhaps even proper nutrition/medical care, etc. Taking into account more than just the number of students in the school will enable the Association to more equitably place schools into appropriate classification levels.

Article 6.3 – Classification of Schools – Computation of ADM

A school’s ADM for the purpose of classification shall include the school’s base number minus the school’s SES factor.

6.3.1. Base Number. A school’s base number shall include the following:

(a) **Public Schools:**

- (1) ADM for grades 9-12 as provided by the Oregon Department of Education for the previous school year, plus
- (2) *All students that participated for your school in the previous school year that did not attend your school (home school students, Associate Member school students, and students at private schools that don’t offer an activity)*

(b) **Private Schools:**

- (1) ADM as provided by the private school to the OSAA for the previous school year, plus
- (2) *All students that participated for your school in the previous school year that did not attend your school (home school students)*

NOTE: For a non-coeducational school, the ADM shall be doubled.

6.3.2. SES Factor. *A school’s socioeconomic (SES) factor shall be subtracted from a school’s base number to create an adjusted base number. The SES factor shall be determined by:*

- (a) **Public Schools:** *Using the school’s free and reduced lunch number as provided by the Oregon Department of Education, multiplied by 25%.*
- (b) **Private Schools:** *Using the school’s free and reduced lunch number as provided by the school to the OSAA, multiplied by 25%. The OSAA shall verify that private schools are following the same household size and income guidelines required by the Oregon Department of Education.*

Proposal to Amend Article 6.2.4 (a) "Petition to Play Down"

(Action Item)

QUESTION: *Should the Delegate Assembly amend Article 6.2.4 (a) "Petition to Play Down" to change the required information a school must submit to the Executive Board when seeking to play down a classification?*

RATIONALE: The current Petition to Play Down language is quite subjective and can be improved using quantitative data not previously available. The proposed new language is based primarily on information compiled by Pete Lulkich, AD at Sunset HS, regarding research he has done and shared with the Classification & Districting Committee relating socioeconomic status (SES) to success in team sports via the OSAA rankings. Specifically, this research factors in a free and reduced lunch percentage combined with final RPI ranking and winning percentages over the last couple of years in team sports to help determine if a school should be moved down from its assigned classification.

Article 6.2.4 (a) – Petition to Play Down

EXCEPTION. OSAA member schools shall participate based upon ADM in the classifications defined in this Article unless an exception has been granted by the Executive Board in response to the submission of a Petition to Play Down.

- (1) Sports and Activities Affected. Any Petition to Play Down granted by the Executive Board shall apply to all OSAA sports and activities in which the member school participates.
- (2) Duration. Any Petition to Play Down granted by the Executive Board shall apply to the classification placement of the petitioning member school during the entire subsequent four-year time block.
- (3) Required Information. A member school submitting a Petition to Play Down shall provide the following information for consideration by the Board. ***Petitioning schools that meet all four criteria listed below shall be automatically approved. Schools meeting some but not all criteria will have their petition reviewed by the Executive Board.***
 - a) ***Documentation showing the school's percentage of students on free and reduced lunch at 50% or higher. ~~League record in all OSAA sports and activities for the previous four years.~~***
 - b) ***Documentation showing that the school's teams finished in the bottom 50% of the final frozen OSAA rankings at least 75% of the time for the previous three years. ~~Overall record in all OSAA sports and activities for the previous four years.~~***
 - c) ***Documentation showing that the school's teams finished in the bottom 20% of the final frozen OSAA rankings at least 50% of the time for the previous three years. ~~Yearly participation numbers in all OSAA sports and activities for the previous four years.~~***

- d) *Documentation showing that the winning percentage of the school's teams in team sports was 25% or less at least 40% of the time for the previous three years. Coaching history in all OSAA sports and activities for the previous four years.*
 - e) ~~Report on number of alternative school students included in ADM calculation.~~
 - f) ~~Letter of current league support or non support for the Petition.~~
- (4) Additional Information. A member school submitting a Petition to Play Down may provide any other information to the Board in support of the Petition including, but not limited to, evidence of intervention undertaken by the district in an effort to address lack of competitive success **and a letter of current league support for the Petition.**
- (5) Submission Deadline. Except as specified in Article 6.2.2 (c), a member school seeking to play in a lower classification than assigned under Article 6.2.4 shall be required to complete and submit a Petition to Play Down to the OSAA prior to **June 1 preceding the December Board Meeting which precedes** the quadrennial October Classification and Districting Meeting.
