

Informational Guidelines 2023-2024 School Year

3. Transcripts

- a. Courses for initial credit will be entered into JMC using the Edgenuity course name.
- b. All courses are GPA weight bearing.
- c. The supervising teacher will be the teacher of record.
- d. If a student transfers to an online course during a grading period
 - i. They will maintain the current grade on their transcript from the class that is dropped.
 - ii. They will be required to complete the entire online course for that grading period.

4. Registration

- a. Parent meeting
- b. Signed form

5. Credit Recovery

- a. Students who need to utilize Edgenuity for credit recovery will have two options:
 - i. Summer Credit Recovery
 - 1. Letters will be sent home with dates for registration and dates for testing
 - 2. All courses not completed within that window of time will be restarted during the school year
 - ii. School Year Credit Recovery
 - Students will be assigned to a study hall where attendance will be taken daily
 - 2. All courses not completed within the semester for 0.5 credit courses or the year for 1.0 credit courses will be restarted at the end of the term.
 - a. Grades will be put into JMC based on the students grade in Edgenuity.

6. Time Frame

Courses for initial credit need to be completed in the assigned time frame (1 semester for 0.5 credit or 1 year 1.0 credit)

Informational Guidelines Initial Credit Courses 2023-2024 School Year

1. Eligibility

a. Any student registered at CI in grades 7-12 is eligible to take courses through Edgenuity during the school year

2. Schedule

- a. Full Time Online Students who are taking six or more courses are considered full time online.
 - i. These courses will be asynchronous and will be monitored by a staff member.
 - ii. Attendance
 - 1. Students are expected to log into each courses assigned to them each day that school is in session
 - 2. Attendance will be marked in JMC by the supervising staff member
 - 3. Truancy procedures will be followed
 - iii. Students will communicate with this staff member via email.
 - iv. Tests will need to be taken
 - 1. In person
 - a. at the school during regular school hours
 - 2. Virtually
 - a. During school hours
 - b. Camera on
 - c. Phone in view
 - d. Monitored with GoGuardian
 - v. Students will not be eligible to attend school events that occur during the school day (Homecoming activities, PBIS reward activities, etc).
 - vi. Students are eligible and encouraged to join CI athletics and activities.

b. Part Time Online

- i. Each student will be assigned to a study hall for attendance and as a work space for courses to be completed.
- ii. Attendance will be taken each hour by the supervising teacher
