TITLE: **Approval of Out of State Travel**

BACKGROUND: **STUDENTS**

Julie Ramsey, Kayla Kipley, and David Watson Sr. from Amphitheater High School request permission to take 17 students from the Varsity Cheer Competition Team to the USA National Spirit Cheer Competition in Anaheim, California, February 22-25, 2018. Approximate cost of the travel is \$5,382 and will be paid for by tax credit donations and student activity funds. No school days will be missed.


