David Apple made a motion to allow open enrollment for students who reside within the City of Coppell on a test basis for the 2011-2012 school year. Scott Orr seconded the motion. The motion passed 4-2. (Warner, Hulme, Orr, and Apple voted in favor. Kemp and Ratliff voted in opposition.)
