The following are donations under \$1000

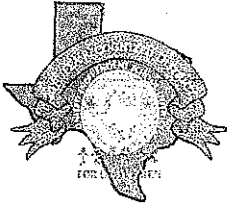
1. Matias De Llano Elementary School 4th grade class received a donation of \$430.00 from fourth grade parents.

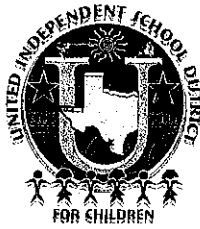
