RESOLUTION PROVIDING FOR A PUBLIC HEARING TO CONSIDER GRANTING A PROPOSED PROPERTY TAX ABATEMENT

BE IT RESOLVED, by the School Board of Independent School District No. 2683, State of Minnesota, as follows: 1. This Board hereby finds and determines that a public hearing shall be held, pursuant to Minnesota Statutes, Section 469.1813, Subdivision 5, to consider granting an abatement of certain property taxes levied against net tax capacity imposed by Independent School District No. 2683 (the "Proposed Property Tax Abatement")

- 3. The purpose of granting the Proposed Property Tax Abatement is to provide funds to finance the construction of and improvements to parking lots at various sites in the District. The total estimated cost of the Proposed Property Tax Abatement by the District is \$168,000 over five (5) years, an amount estimated to be sufficient to pay the principal and interest charges on approximately \$150,000 of bonds issued to finance parking lot construction, reconstruction and improvement districtwide and related financing costs.
- 4. The public hearing to consider the granting of the proposed tax abatement shall be held at 7:30 o'clock p.m., on March 21, 2022, in the School Library, 401 Park Avenue West, Greenbush, MN 56726. The clerk is authorized and directed to cause notice of the hearing to be published in a newspaper of general circulation in the school district at least one time more than ten (10) days but less than thirty (30) days before the date of the hearing. The newspaper must be one of general interest and readership in the community and not one of limited subject matter. The newspaper must be published at least once per week. The Notice of Public Hearing shall be in substantially the form of the Notice attached hereto as EXHIBIT A and shall contain instructions as to how to connect with the hearing electronically or by telephone.
- 5. All who wish to be heard as to the Proposed Property Tax Abatement will be given an opportunity to express their views at the time of the public hearing or may file written comments with the Superintendent prior to the public hearing.
- 6. All actions taken by the school district to cause the publication of the attached Notice of Public Hearing prior to the date of this resolution are hereby ratified, confirmed and approved.

The motion for the adoption of the foregoing resolution was duly seconded by Brandon Kuznia, and upon vote being taken thereon, the following voted in favor thereof: Kilen, Kuznia, Ignaszewski, Harder, Stenberg and Howard
