

## RESOLUTION 12-53 Contracts for TSPC Licensed Contract Teachers for 2012-2013

### Background:

March 20, 2012, the Board took action on Resolution 12-32 extending the contracts for TSPC Licensed Contracted Teachers for 2012-2013 and were approved as follows:

Since that approval the following contracts have been decreased or increased based on funding:

- Early Childhood Evaluation Specialist has been eliminated due to budget reductions. Ms. Buhl, through bumping/RIFing rights, has accepted a new position as a 190 day employe at .8 FTE.
- Teacher, Special Education reduced from 190 days at 1.0 FTE to 190 days at .8 FTE at the request of the employee.
- Four Teachers, Special Education increased from 185 days to 190 due to furlough days being reinstated for 2012-2013.
- Supervisor, DOI, Special Education increased from 225 days to 230 due to furlough days being reinstated.

**WHEREAS** ORS 342.895 requires the Board to decide on the extension or nonextension of the employment contracts of Contract Teachers, and

**WHEREAS** the Programs and Services Proposal 2012-2013 has been formulated based on the anticipated receipt of the funds necessary to support most of the programs in which the employees listed below will be assigned, and

**WHEREAS** in the event the anticipated resources are not received, each and every program is subject to reduction or elimination at the discretion of the Board.

**NOW THEREFORE BE IT RESOLVED** that the employment contracts of the following contract teachers are approved for the 2012-2013.
