Resolution of the Board to Set Tax Rate

September 17, 2024

On this date, we, the Board of Trustees of Wharton County Junior College, hereby levy or set the tax rate on \$100 valuation for the College for the tax year 2024 at a total tax rate of \$0.1328, to be assessed and collected by the duly specified assessor and collectors as follows:

\$0.1328 for the purpose of maintenance and operations.

Such taxes are to be assessed and collected by the tax officials designated by the College.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 7.9 PERCENT AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$5.10.
