AGENDA ITEM: 9.3

TOPIC: Approve School Bus Leasing

BACKGROUND: The Minnesota Department of Education allows Bus Leasing. Limited funding has forced school districts to examine alternatives ways to replace older school buses. Forest Lake Area Schools has been leasing regular and special education buses for several years. The school district's finance committee supports using bus leasing to replace some of the district's aging fleet.

PROCESS: The Transportation Department requested permission to lease 14 new, 2017 - 77 passenger school buses to replace the expiring 2015 models currently under lease, using the Minnesota State Bid Contract with Hoglund Bus Company.

The Transportation Department also requested permission to lease 9 new, 2017 - 77 passenger school buses and to trade in 9, 2001 buses using the Minnesota State Bid Contract with Hoglund Bus Company.

RECOMMENDATION: Administration recommends approval of leasing buses from Hoglund Bus Company according to the description above and portions of the attached document.
