Enrique Rangel: Good evening, we bring tonight for approval after careful consideration of Second Amendment & Contract Related Fees of Guaranteed Maximum Price for Design and Construction of the new Aquatic Center between UISD and Design Builder Leyendecker Construction of Texas for RFQ 028-2015 Aquatic Center. At this time the administration is recommending the approval of the Second Amendment and the Guaranteed Maximum Price in the amount of \$18,470,205.75 this does include a contingency allowance of \$300,000.00. This GMP has been submitted with a breakdown of all the actual costs that you'll find there in your board book. It was broken down as part of the RS Means Cost Index to ensure that it is a price within the handbook and construction guidelines. We went through a very detailed process of value engineering to make sure that we get the best/most effective cost on this project and ensuring that this facility

provides state of the art aquatic center facilities for our students and will provide great benefit for years to come. Mr. Enrique Rangel continues to address the breakdown information previously provided. Also, Mr. Rangel notes that this project is not being funded through the 2013 Bond fund.
