### 3. Recognitions

### 3.a. Valedictorians

Dr. Bret Champion greeted and commended the 2020 valedictorians who were attending the meeting virtually. Principals Mr. Daye Stone, Central Medford High School; Ms. Wendy Ross, Medford Online Academy; Dr. Dan Smith, North Medford High School; and Mr. Donnie Frazier, South Medford High school, spoke regarding the outstanding accomplishments of the valedictorians. The valedictorians were introduced and shared their college/career plans following graduation.

### 3.b. Presidential Scholar Semi-finalist

Dr. Champion commended South Medford High School senior Yosalin Arenas for her student representation at the state level and acknowledged the accomplishments of receiving the Presidential Scholar Semi-finalist award and receiving the Ford Family Foundation Scholarship. Ms. Arenas provided a summary of her college and career plans following graduation.

#### 4. Public Comments

The meeting was closed to public attendance. The public was provided an opportunity to submit written comments prior to the meeting. Vice Chair Suzanne Messer read the comments into the record.

**Jessica Seyfer-Scott/Parent**/Expressed concern regarding the COVID-19 precautions that will be implemented for the 2021-22 and was in opposition of students wearing masks.

**Star Gordon/Parent**/Provided comments in opposition of students wearing masks during physical activities and sports.

**Courtney Caswell/Parent/**Provided comments in opposition of students wearing masks and requiring mandatory COVID vaccination.

Vice Chair Messer read the following statement in response to a letter sent to the Board from the Oregon Education Association (OEA) UniServ Representative Daniel Burdis.

"The Medford School District Board of Directors acknowledges receipt of a letter from Daniel Burdis, OEA UniServ, regarding bargaining and the recent premium holiday, however before commenting or responding, the Board will discuss the communication with the district in a future executive session that has been properly noticed for the purpose of bargaining."

Following the public comments, Dr. Champion provided the Board with the updated Ready Schools, Safe Learning (RSSL) guidelines from Oregon Department of Education (ODE) regarding mask guidance for indoor and outdoor environments, including sports and graduation ceremonies. He also addressed the comment regarding critical race theory.

Board Directors put forth questions and comments regarding:

- Monitor the guidelines for fall and possibly engage the Board in writing a letter to ODE/Oregon Health Authority
- Optimistic the current masking guidelines will be modified/wait to see fall RSSL
- Stay vigilant with ODE required curriculum
