RESOLUTION TO LEVY 2025 PROPERTY TAXES

WHEREAS, the Board of Education is authorized by Article 17 of <u>The School Code</u> (105 ILCS 5/17-1 et seq.) to levy special taxes for various school purposes;

NOW THEREFORE, BE IT RESOLVED by this Board of Education of West Chicago Elementary School District No. 33, County of DuPage, State of Illinois, as follows:

Section 1: The following amounts of money, as set forth below and as indicated on the Certificate of Tax Levy attached to and made a part of this Resolution, shall be raised by special taxes for the various purposes of said District:

The sum of \$37,750,000 to be levied as a special tax for educational purposes; and The sum of \$4,841,084 to be levied as a special tax for operations and maintenance purposes; and

The sum of \$3,000,000 to be levied as a special tax for transportation purposes; and
The sum of \$461,346 to be levied as a special tax for working cash fund purposes: and
The sum of \$306,752 to be levied as a special tax for Illinois Municipal Retirement purposes; and

The sum of \$508,819 to be levied as a special tax for Social Security purposes; and The sum of \$19,476 to be levied as a special tax for tort immunity purposes; and The sum of \$3,650,593 to be levied as a special tax for special education purposes.

Section 2: The President and Secretary are hereby authorized and directed to sign the Certificate and file or cause the same to be filed with the County Clerk of DuPage County on or before the last Tuesday in December of 2025.

Section 3. This Resolution shall be in full force and effect upon its adoption.
