Trustees Stacy Anne Arias and Jenny McCall were not in attendance. Other attendees included District President H. Neil Matkin, Collin College administrators, and staff.

CALL TO ORDER

2015-8-1-2 Approval of 2015 Calculated Effective Tax Rate and Rollback Rate

BE IT RESOLVED, at the recommendation of the District President, that the Board of Trustees of Collin County Community College District approves the 2015 Calculated Effective Tax Rate and Rollback Rate.

Interim Vice President of Administrative Services/Chief Financial Officer Julie Bradley presented information to the board on the 2015 calculated effective tax rate and the rollback rate.

Chair of the Budget and Finance Committee Andy Hardin reported on that committee's recent meeting to review the proposed 2015-2016 budget. He said that when the committee looked at the proposed budget using tax numbers, the effective tax rate and roll back rate had not been certified. At that time, the committee looked at figures prepared with the 2014 tax rate. Trustee Hardin said the committee would meet again prior to the end of August to discuss the tax rate and the proposed budget for 2015-2016.

On motion of Mr. Wainwright, second of Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the 2015 Calculated Effective Tax Rate of \$0.076276 per \$100 of assessed value and the Rollback Rate of \$0.082356 per \$100 of assessed value.
