



Visual and Performing Arts Festival:

This Visual and Performing Arts Festival has been an annual event for the past 21 years. This years festival had over 250 participants from Cooperative districts. We were honored to have Melinda Williams from Williams Baptist University as our emcee. Mrs. Williams has taught at WBU for 39 years. She is currently the Director of the Liberal Arts Program and the Assistant Professor of Communication Arts. She the Co-Director of The Cast, WBU's traveling drama ministry. When she isn't teaching, she can be found directing two mainstage productions for WBU each year as well as writing and directing for The Story Store.

Teacher Day: NEA Cooperative hosted their annual "Teacher Day" on August 10, 2022, at the Westside School auditorium.

The morning session training was on exploration of topics such as types of trauma, the impact of trauma on brain development, maintaining emotional safety during a crisis, and application of key concepts to real-life scenarios. The event was presented by the Trauma Resource Initiative.

The afternoon session was "Starting the Year off Right, Classroom Management, and Parent Engagement". Topics presented included Starting the Year off Right, Classroom Management and Parent Engagement. This will meet the required PD, Parent Engagement, for the 2022-2023 school year.

Athletic Coaching Institute:

The Athletic Coaching Institute is a two-day annual collaboration between ASU, Crowley's Ridge Education Cooperative and the Northeast Arkansas Education Cooperative. For over a decade Ron Carrol, director of the Institute, has provided trainings on-site at ASU on a variety of topics.

GOAL:

The Northeast Arkansas Education Cooperative Early Childhood ABC programs will ensure that all Arkansas children and families that we serve have access to a safe, high-quality, developmentally appropriate environment by educating and assisting parents and communities to prepare our children for future success.

PROGRAM SUMMARY:

The Northeast Arkansas Education Cooperative ABC programs consists of 20 classrooms across 8 sites.

- Staff Qualifications-Each preschool classroom has a licensed Early Childhood teacher and one teaching assistant that has completed an Associate's Degree, has CDA certification or is working toward certification. A floater is also employed at each site. All staff, including floaters and substitutes are required to take an 8-hour New Staff Orientation training, which provides a general overview of the rules and regulations pertaining to the program.
- Licensing: All programs have met Quality Approval Child-Care standards. Seven of the 8 sites have had their licenses renewed during the 2022-23 school year, and all 7 maintained their Level 3 Better Beginnings rating. The 8th site will have their license renewed next fall.

MAJOR HIGHLIGHTS OF THE YEAR:

- 1. Gaining a deep understanding of the principles and practices that build and support a quality early childhood program.
 - (a) ABC Coordinator PD hours: 325

- (b) During the 178 student contact days, the ABC Coordinator spent 88 days visiting one or more classrooms
- (c) ABC Coordinator spent 3 days substituting in classrooms
- 2. Director, ABC Coordinator, and staff worked together to implement practices that will be most impactful for the program, including:
 - (a) ABC Coordinator, teachers, and paraprofessionals collaborated to select a high-quality comprehensive curriculum. Frog Street was ultimately selected, purchased and delivered to all 20 classrooms.
 - (b) Requested numerous TA (technical assistance) visits from A-State program specialists to visit classrooms and provide assistance in bringing classrooms and playgrounds up to ECERS (Early Childhood Environment Rating Scale) standards;
 - (c) Installation of new playgrounds at all 8 sites is in progress
 - (d) All teachers implemented Launchpad (Science of Reading)
 One teacher shared her pre-and post-testing, which revealed that 18 out 20 students showed growth in phonemic awareness and letter recognition.
 - (e) Updating staff files, including substitute teachers, and providing notification and support to personnel needing required professional development.
 - 1. ABC and HIPPY Coordinators achieved CPR Instructor status and provided CPR training to staff on February 17, 2023
 - 2. Hosted a workday for substitute teachers to assist them in completing the mandated New Staff Orientation training
- 3. Collaborating with the ABC staff to make sure that the students have lots of "learning through fun" opportunities , including, but not limited to, the following:
 - (a) Nature walks
 - (b) Scientific experiments and experiences such as hatching chicks in an incubator, planting seeds and caring for the seedings and flowers, preparing a worm bed, caring for classroom pets (hamster, goldfish), trying new foods and describing the taste (sweet, bitter, etc.) and texture (creamy, crunchy)
 - (c) Lot of opportunities to grow gross and fine motor skills as well as social skills through play, art, meal times, and so much more.
 - (d) Every single child received a present delivered from Santa himself that contained books and other learning toys.
 - (e) Each site hosts a graduation as well as a "fun day" at the end of the school. During the fun day, students are treated to a day full of games, bounce houses, cotton candy, and snow cones.

This BX3 project is designed to build capacity by providing coaching to building-level behavior teams that are working to develop tiered systems of positive behavior supports for all students. BX3 assists building level teams in developing and monitoring at least one SMART goal based on their assessment on the Tiered Fidelity Inventory (TFI). Additionally, the BX3 teams create and update an action plan focused on meeting their individualized SMART goal(s). The BSS offer at least 6 coaching sessions (one per month) for each BX3 team. Professional learning opportunities are offered as needed based on the SMART goal(s) and action plan.

3. Licensure - Successful implementation of computer science education in Arkansas requires the ADE and its partner organizations to anticipate and address the needs of the Arkansas educational system with regards to licensed and endorsed computer science teachers. ADE will continue and further research and implement, when appropriate, flexible licensure pathways and practices, based on legislation and regulation.

4. Outreach and Promotion - Successful implementation of computer science education in Arkansas requires the active use of a broad range of mediums, digital tools, and human networks to properly communicate about the Arkansas Computer Science Education Initiative and respond to the needs and concerns of Arkansas students, educators, community members, and industry leaders.

5. Program Growth and Student Success - Successful implementation of computer science education in Arkansas requires encouraging broad school implementation, supporting lighthouse schools to expand their programs, increasing statewide teacher capacity, growing student interest, and increasing stakeholder interest and support through the use of innovative programs and outreach initiatives.

PROGRAM SUMMARY: The Early Childhood Special Education program serves children in 6 Head Start locations, and 20 private daycare centers, as well as all of the ABC classrooms that are located on the 11 school campuses. Several more Early Intervention Day Treatment (EIDT) centers are opening in the Jonesboro and Paragould areas. This makes approximately 15 EIDT locations that we are now providing services to children. Since COVID, some parents are still choosing to attend the conferences by alternate means such as phone and video. We are happy to accommodate these requests and are learning better ways to conduct these types of conferences. The program continues to cooperate with the area AASEA group. This is a collaborative relationship among the Early Childhood coordinators and the LEAs for the schools that serve the preschool and school age special education population in our region.

GOAL:

The goal of the Northeast Arkansas Education Cooperative's Gifted and Talented Program is to assist member districts in coordinating, implementing, evaluating and improving local programs for gifted and talented youth. This goal is pursued through two primary objectives: (1) to develop and implement the Co-op's technical assistance activities in gifted education and to assist member districts to meet the standards for gifted and talented education; and (2) to provide a liaison with the office of Gifted and Talented Education, DESE, parent and professional organizations, and other public and private agencies and conduct public awareness and advocacy programs.

PROGRAM SUMMARY:

During the 2022-23 school year a broad range of services were provided that incorporated the five strands: on-site consultation and technical assistance; curriculum materials and resources; in-service and staff development; K-12 student activities; community involvement, and professional development activities. Specific needs of school district G/T Coordinators, Facilitators and students were addressed through the following activities and /or presentations: Project Fair for students in grades 3-9; a creative writing project called the Story Store for students in grades 3-6; Four Quiz bowl competition for students in grades 3- 12; Odyssey of the Mind competition for students in grades K-12; and Business Expo in grades 5-9,

Staff development opportunities included: Whole Group Enrichment; Chess Strategies along with on-going work on our GT Frameworks. GOAL:

HIPPY's goal is to assist parents in laying a foundation for future school success by providing educational enrichment to their preschool children. HIPPY offers parents with support, training, and materials so they can engage in developmental and effective activities with their children. We believe parents are a child's first teacher and every child should enter kindergarten prepared and ready to learn. HIPPY inspires and promotes interactions that lead to success. We empower parents as their children's first teacher by giving them the tools, skills, and confidence they need to work with their children in the home. Families participating in HIPPY receive all books and learning materials free of charge from their local program.

PROGRAM SUMMARY:

HIPPY is a developmentally appropriate, early literacy curriculum designed to promote children's cognitive, social, emotional and physical development. The curriculum consists of a set of easy-to-use educational activity packets and storybooks developed for parents of children ages 2-5. Parents engage with the curriculum by role playing the parent-child activities

with a home visitor who is from the same community, and often a former HIPPY parent. All home visitors are supervised by a professionally trained program coordinator. Through the delivery of the HIPPY curriculum home visitors empower parents to build strong relationships with their children through activities and engagement that prepare them for school. The HIPPY model has four components:

- Curriculum
- Role Play
- Coordinators & Home Visitors
- Home Visits and Group Meetings

Each of the four features of the HIPPY model was chosen and developed in order to allow participation from parents who might otherwise not get involved with their children's education. Although HIPPY is for any parent who wants educational enrichment for his/her child, the HIPPY model was designed to remove barriers to participation due to lack of education, poverty, social isolation and other issues.

MAJOR HIGHLIGHTS OF THE YEAR:

- The NEA Education Cooperative HIPPY program served 90 families this year with a total of 97 children. Some families include: single or divorced parents who are trying to raise children on their own, foster parents, and grandparents who are starting parenting again with grandchildren.
- Cheryl Gookin was awarded 10 years of service from the HIPPY Arkansas office. She is our HIPPY HBE that serves families in Clay county.
- Monthly parent meetings have included Fall field trips to Pumpkin Hollow and Autumn Woods. Healthy meal ideas for families with hands-on cooking; a Winter celebration; a visit from Cat-In-The-Hat during Dr. Seuss month that included book rewards for participation in a month-long reading contest, visits from kindergarten teachers from various schools to inform parents of the school's expectations as well as what parents can do to make their child's educational experience optimal, visited and toured local fire departments to learn about Fire Safety and what children can expect when they see a firefighter in full uniform, and ended with a End of Year Celebration at Ultimate Air Trampoline park to celebrate the 19 HIPPY Program graduates.
- Advisory Team was made up of 21 individuals from each local community of the 5 counties we serve. We had 3 meetings this year held at the NEA Education Coop. The luncheons included guest speaker, Gregg Cooper, ABC Coordinator, as he spoke on Adverse Childhood Experiences and guest speaker from UAMS, Kimberly Whitman, LCSW, on the topic of Identifying & Recognizing the signs of Childhood Trauma.

Goal: To provide the support, assistance, training and encouragement to the Novice Teachers from among the 13 participating NEAEC member school districts in order that each NT can become an effective, knowledgeable teacher and remain in the teaching profession.

PROGRAM SUMMARY:

The **Recruitment and Retention Facilitator** mentored **187 Year 1, Year 2 and Year 3 Novice Teachers** in the school year 2022-2023.

Multiple sessions were conducted with Novice Teacher Year 1, Year 2, and Year 3 during the summer months throughout the school year. Connections were made with the new teachers when and as they were hired. During those informal meetings, the Recruitment and Retention Facilitator regularly communicates with all Novices to provide teachers with updates and gathers data to determine assistance needed. Year 1 NT's were provided elemental training on EscWorks, Arkansas Ideas, and other websites that would be used during their upcoming year in order to be "Day One Ready" for the first day of school. Year 2 and 3 Novice Teachers met in several group meetings at points of availability. R&R and teachers discussed the methods of delivery of instruction planned for each at their individual schools to determine training needs. Training sessions that were provided during the school year are listed below. These sessions were provided both live at the Cooperative and by Zoom. The Novice Teacher Program provided partial payment to district subs allowing NT's to attend these trainings.

There were **4 Novice Teacher Year 1 Days** conducted live in summer sessions and virtual sessions during the school year:

PROGRAM SUMMARY:

The office of the Science Specialist assists teachers, administrators, and schools by providing quality professional learning opportunities and ongoing, site-based support in instruction, leadership, and best practices in science education. Instructional support such as statewide science professional development (e.g., Grasping Phenomenal Science) was provided to aid implementation of the Arkansas K–12 Science Standards, model and provide resources for phenomena-based instruction, and incorporate ELA and Math standards. Support of Science Novice teachers was provided though on-site visits and observations. Science content was addressed through various texts, such as Disciplinary Core Ideas: Reshaping Teaching and Learning, Helping Students Make Sense of the World: Using Next Generation Science and Engineering Practices, and Crosscutting Concepts: Strengthening Science and Engineering *learning*, which inform K–12 science content while addressing ELA standards, science inquiry, and storyline model of instruction. On-site visits provided coaching support for the creation and delivery of phenomena-driven lessons, classroom management, and assessment tasks. Professional learning opportunities for science focused on awareness of, transition to, implementing, or sustaining the Arkansas K–12 Science Standards, STEM integration, and the Solution Tree PLC process. An Innovative Partnership with WBU was continued this year to bring pre-service teachers direct awareness of the Arkansas K–12 Science Standards through instruction with the Grasping Phenomenal Science PD sessions. GOAL: Arkansas's Science, Technology, Engineering and Mathematics STEM Initiative is a coordinated effort among the state's mathematics, science and career and technical STEM education units and personnel to transform Arkansas to lead the nation in student-focused and career-minded science, technology, engineering, and mathematics education.

PROGAM SUMMARY: The office of the State Science Specialist supports Science Specialists, schools, teachers, and administrators by analyzing GPS and Cadre Survey Data, implementing FY 2020 plan for GPS PD revision and development based on data, including district needs surveys, implement a Cadre follow-up support system and develop science curriculum and assessment resources accessible to Arkansas teachers. Mentoring and support was provided to the educational service cooperative science specialists through guiding, planning and implementing school support based on Grasping Phenomenal Science (GPS) strategies and goals and ACT Aspire Data, providing professional development to the specialists, and assisting ESC specialists in meeting their grant objectives. Mentoring and support was provided regionally through this position, with five different cooperatives being supported, Northeast, North Central, Crowley's, Arkansas River and Great River. GPS PD that was created and/or revised for FY 2020 was Unit Development, Science Assessment, and ACT Aspire and the Practices. Rehearsals for each of the PD's were held with each Science Specialist, while sharing tools and resources essential for delivery and implementation. A K-12 Unit Development pilot was also implemented with teachers from the NE Education Cooperative, consisting of over 75 teachers representing Kindergarten through Chemistry. These grade banded groups met each month from October to March, while engaging in a step by step process of a modified version of Understanding by Design. Products that were created were a scope and sequence for the year, phenomena driven PE bundles, essential questions and enduring understandings, assessment tasks and lesson level plans. This process will continue over the summer and throughout the next school year. During the last quarter of the school year, with AMI learning methods in place, bulleted lists of learning activities were created from PBS programs for Pre-K-8th grade students, along with vetted lists of content resources, strategies and tools for all grade levels. GPS PD session ACT Aspire and the Practices is being converted to a digital platform, in order to meet the needs of teachers over the summer.

Mission: Educators Rising is cultivating a new generation of highly skilled educators by guiding young people on a path from high school through college and into their teaching careers. Educators Rising is changing the face of teaching by working with aspiring educators who reflect the demographics of their communities and are passionate about serving those communities through public education.

Vision: A clear pathway in every school district in America for young people who want to serve their communities as highly skilled educators.

GOAL:

To work with regional partners and school districts to strengthen the presence of Educators Rising in Arkansas

Program Summary:

Educators Rising is a career and technical education (CTE) movement that aims to inspire high school and college students to serve their communities by entering the field of education. By establishing a pathway starting in high school, Educators Rising assists districts in cultivating their own next generation of highly skilled educators through a "grow your own" initiative. In addition, Educators Rising strives to diversify the educator workforce as future educators explore the necessary skills to teach equitably and add student voice to national discussions around education. The Educators Rising program is a state affiliate of the national Educators Rising organization administered by Phi Delta Kappa International. As a state affiliate, schools with pre-educator programs have access to student micro-credentials, rigorous curriculum and standards, scholarship opportunities for students, EdRising Virtual Campus (resources, videos, and lesson plans), and opportunities to network through the region, state, and national events.


Counties rather than ESC boundaries determine the EdRising regions. However, Region Three is composed of districts from Crowley's Ridge ESC and Northeast AR ESC.

MAJOR HIGHLIGHTS OF THE YEAR

Through collaboration between the Region Three Coordinator, CRESC facilitators, and the AState Department of Teacher Education faculty, the 3rd annual Region Three Educators Rising Conference and Competitions took place on the campus of ASU on November 16, 2022. Over 100 students and guests from participating districts were present. Conference attendees heard the 2022 Arkansas Teacher of the Year, Jessica Saum, give the morning keynote address. The afternoon keynote speaker was Mr. Ross White, Director for DCTE. Interspersed throughout the day were presentations from experts in their fields, with interactive sessions for student engagement and visits to booths set up by various universities across the state. The conference concluded with awards presentations for the competition winners. Jennifer Snyder, CTE Coordinator, concluded the day's events with the awards ceremony.

Students from participating districts competed in the categories of "Children's Literature-Pre-K," "Creative Lecture/Ted Talk," "Impromptu Speaking," "Project Visualize," "Interactive Bulletin Board," "Public Speaking," "Educators Rising Moment," "Ethical Dilemma," "Lesson Planning and Delivery," "Teacher Created Resources," "Inside Our Schools," and "Job Interview." First-place winners qualified to compete at the National Educators Rising Conference in Orlando, FL, in June 2023.

The Region Three Coordinator worked with a select committee of state and regional coordinators to plan the Arkansas Educators Rising State Conference, held at ASU in Jonesboro on March 28, 2023. Over 250 students from across the state attended the on-site conference, with several attending from Region Three. The 2023 Teacher of the Year, Capri Salaam, was the keynote speaker. Topics for conference sessions included Say Something!, Engage Your Brain!, Engaging and Including, and Brain Breaks. EdRising chapter sponsors and members attended sessions targeted to their needs. Those who placed first went on to compete in Orlando, FL, during the national summer conference.



Communities of Practice (CoP)

Description:

Building Communities of Practice (CoP) is focused around Identifying Learning Loss and Accelerating Learning using High-Quality Instructional Materials (HQIM). DESE, in partnership with a national partner, will bring together groups of Arkansas system leaders (district and school teams). The Community of Practice will explore the leadership practices necessary to implement math and/or literacy instruction and learning supports that meet the moment, while staying focused on long-term recovery and acceleration goals.

The CoP includes a series of sessions that includes research and evidence-based strategies to address and plan for the acceleration of learning using HQIM.

Grantee will select vendors from those approved by Rivet Education to contract with for professional services to engage in content coaching, with emphasis on HQIM.

Arkansas Professional Educator Pathway (ArPEP) Number Trained: ***participants in Cohort 1

Description:

The Arkansas Professional Educator Pathway (ArPEP) is an affordable two-year, work-based training, alternative education route to obtaining an Arkansas standard teaching license for college graduates or career changers holding at least a bachelor's degree. ArPEP's goal is to prepare learner-ready teachers to meet the growing demand of the teacher pipeline in Arkansas. The primary objective of ArPEP is to train future educators on how to build classroom communities, design effective lesson plans, implement evidence-based instructional strategies, and use assessments to facilitate student learning.

The ArPEP facilitator will prepare educators who understand what accomplished beginning teaching looks like in a classroom, and more importantly, demonstrate how effective teachers design lessons, provide instruction, build classroom communities, and utilize assessments to facilitate student learning.

Professional Learning Communities: Boardroom to Classroom - In support of the DESE's PLC Initiative, Co-ops have been participating in the Boardroom to Classroom trainings monthly with Janel Keating from Solution Tree. As part of this process, Janel Keating guided educators in developing successful districtwide professional learning communities to ensure high levels of learning for every student. High-performing districts develop when collaborative teams at every level align their concepts, practices, and vocabulary. Aligning this work is a top-down, bottomup cyclical process, starting with the district level and ending with collaborative teacher teams. This session provided district and school leaders with the tools and strategies needed to create a districtwide culture of continuous improvement. Co-ops are an integral part of this work, and have been supporting districts involved in these sessions through Specialist support, and working with administrators who are implementing PLC processes.

ESC Evaluation Description:

Per Ark. Code Ann. § 6-13-1020 and <u>Rules Governing Education Service Cooperatives</u> Sections 21.00 and 22.00, all active Education Service Cooperatives must be evaluated at least once every five years and include the results in the annual report submitted to the Department of Education. The evaluation schedule is determined by the Commissioner of Education and conducted by an evaluation committee of no more than nine people. The committee is made up of local stakeholders, educators, representatives for higher education, and parents.

The evaluation process includes an investigation of user satisfaction, service adequacy, extent of local financial support, staff qualifications, and performance and administration effectiveness. This information is shared with the committee via a cooperative team. The evaluation committee reviews the evidence for each component, as well as conducts interviews with a variety of stakeholder groups: administrators, cooperative employees, regional educators, and special focus groups determined by the cooperatives. The interviews allow regional districts the opportunity to express their satisfaction and concerns regarding the manner in which the cooperative is operating and fulfilling the needs of the schools.

At the conclusion of the on-site visit by the evaluation committee, the committee indicates the cooperative's levels of success in each category using the criteria outlined in the rubric found in Appendix 2 in the Rules document. Each section of the rubric is scaled from 1 ("in need of immediate support") to 5 (excellence"), and the cooperative is assigned an overall rating of 1 to 5. The final report of the evaluation is presented to the cooperative, region districts, and the State Board of Education.

The Northeast Arkansas Education Cooperative evaluation occurred on November 16, 2022. Our cooperative received an overall rating of 5. Our FINAL EVALUATION REPORT was presented to the State Board of Education and was accepted.

Act 1082 Support

While literacy coaching is a part of the ESC literacy specialists' work, it is just one of many workstreams for these individuals. As a result, districts receive varying intensity of support from literacy specialists, based on their ADE Progressive Levels of Support classification, and the fact that not every school that needs support receives it. Arkansas has 5 levels of support (General, Collaborative, Coordinated, Directed, and Intensive) determined, in part, by a district's student reading outcomes on the state summative assessment. Arkansas literacy specialists support only Levels 3-5:

• Level 5 - Intensive Support: ADE literacy specialists conduct weekly site-visits to provide coaching and feedback in schools. Arkansas currently has five districts at this level. The percent of students that met the ACT Aspire readiness benchmark in these districts is just 13.86%, compared to a statewide average of 35%. Of the Level 5 districts, 3 have adopted approved HQIM in K-3, 1 has adopted approved HQIM in K-2 but not grade three, and one district has not adopted HQIM.

• Level 4 - Directed Support: ESC literacy specialists provide support to districts in their region including coaching teachers, model lessons, walkthroughs with principals and professional development around the Science of Reading. Arkansas has 37 districts that receive this support. The percent of students that met the ACT Aspire readiness benchmark of these districts is 21.95%. Of the districts, all but one have adopted approved HQIM in K-3.

• Level 3 - Coordinated Support: ESC literacy specialists provide support to districts in their region including coaching teachers, model lessons, walkthroughs with principals and professional development around the Science of Reading. Arkansas has 67 districts that receive this support. The percent of students that met the ACT Aspire readiness benchmark of these districts is 27.91%. Of the Level 3 districts, 29 have adopted approved HQIM in K-2, 7 have partially adopted HQIM in K-3, and 1 has not adopted HQIM in K-3.

Act 1082 is designed to provide specific levels of support to public school districts based on reading scores.

The goals of this support include helping schools deploy more powerful strategies, use resources more productively, and analyze the curriculum that is used. To that end, both Level 3 and Level 4 schools meet periodically with the Public School Program Advisor from the DESE and the co-op team either virtually or in-person. Level 3 schools are required to meet once every nine weeks and Level 4 schools meet monthly. During these meetings a spreadsheet is reviewed that includes the topics: Literacy Curriculum, Assessments, Science of Reading, Dyslexia, and Writing Revolution. This spreadsheet is a living document that all stakeholders can update as actions are taken in support of any of the given areas.

ESC Literacy specialists also provide regular support throughout the year to these schools. This support can be in the form of model teaching, professional development for teachers and/or paraprofessionals, classroom walkthroughs with principal, or anything that is identified by the school or in the coordinated meetings. The professional development opportunities are designed to provide personalized support to ensure that all teachers acquire the instructional expertise needed to educate all students and improve reading skills.

Marvell-Elaine Instructional Support

The Marvell-Elaine School District was placed on Level 5 in November 2022. Subsequently, their waiver for student enrollment size was denied in December 2022. With these two events, a report of a high percentage of teachers not being licensed in their teaching assignment, and a realization that the district was in need of high quality instruction for secondary students, the Office of Coordinated Support and Service requested for Cooperatives to provide direct instruction in the English Language Arts, Mathematics, Science, and Social Studies classrooms at Marvell-Elaine High School. The subject-area leads for the project were: Terri Guy, OCSS (ELA); John Hoy, OCSS (Math), Patrick Quattlebaum, Great Rivers (Science), Kelsey Riley, Great Rivers (Social Studies). The goal of this project was to provide high quality instruction to the seventh through twelfth grade students during the third and fourth nine weeks of the 2022-2023 school year.

Cooperative directors and teacher center coordinators were asked to commit to bringing a team of at least five individuals to provide instruction– two for ELA, one for Math, one for Science, and one for Social Studies. The Northeast Arkansas Education Cooperative sent a team of six, comprised of the Coop Director, TCC, two Literacy Specialists, Science

Specialist, and Math Specialist, to provide instruction to the students of the Marvell-Elaine School District High School. The team, along with two specialists from the Northwest Arkansas Education Coop, spent the week of April 3-6.

Goals and Description:

Northeast Arkansas Education Cooperative technology coordinators continue to provide support to district testing and technology personnel as needed. Available support includes onsite visits within districts to aid in preparing technology infrastructure, providing training opportunities for ACT Aspire updates, and hosting ACT Aspire workdays to help with data entry and test scheduling. Additionally, cooperative technology coordinators provide ongoing assistance through emails and phone conversations as problems and questions arise in districts.

The Northeast Arkansas Education Cooperative also provided support to classroom teachers and instructional leaders to ensure Arkansas content standards were taught in a manner that would prepare students for the ACT Aspire. In addition to ADE presenters, cooperative content specialists provided face-to-face trainings on ACT Aspire resources and their use in strengthening the classroom teachers' understanding of assessment requirements for students. Trainings continued during the summer of 2020 with the upcoming trainings planned for the school year.

In cooperation with APSRC, the NEA Education Cooperative provided local school board members opportunities for training to fulfill their board certification requirements. Trainings were provided in two virtual sessions in October. **Legal Training for School Boards** was provided both nights by Scott Smith, Director, APSRC; Robert Brech, General Counsel, APSRC; and Tripp Walter, Staff Attorney, APSRC. Legal Training for School Boards included the following Topics: Freedom of Information Act, Board Governance & Responsibilities, New Laws Affecting School Boards, Legislative Update, and School Safety, Ethics, FMLA, Student Discipline, Medical Marijuana, ESSA, Homeschool/Private School. **Finance Management Training** was provided both nights by Ken Rich, Director of Finance Services, APSRC. Finance Management Training included the following topics: School Funding FY20, 2019 Legislative Update, How to Read and Interpret and Audit, Enhanced Student Achievement Funding, Background Checks for Classified Employees, Minimum Salary Requirements, Adequacy, and Audit Findings, Financial Management – Living within you Means, Fundraising/Crowdfunding, Special Education Catastrophic Funding, Fair Labor Standards Act – Overtime Rules, Procurement, Audit Findings.
