SCHOOL BOARD  
DECEMBER 16, 2025

Vice-Chair C. Anderson called the meeting to order at 4:33 PM with the following present: Vice-Chair C. Anderson, Clerk Livingston, Directors Swor, and Yener, Superintendent Tucci Osorio, and Student Board Representatives Orozco. Arriving at 4:37 PM Directors Nitardy and Rosemark. Absent: Chair Yang.

Others present were: Andrew Beaton, Assistant Superintendent; Tricia St. Michaels, Assistant Superintendent; Sara Guyette, Director of Operations; Amylee Yang, Director of Human Resources; Jeff Cavett, Skyview Principal; Jill Miklausich, John Glenn Principal; and May Her, Executive Assistant.

The meeting opened with the Pledge of Allegiance.

Livingston moved and Swor seconded the following motion, which carried on a 4 – 0 vote:  
THAT the agenda be approved as presented.

During the Public Comment portion, Peter Provost, Gary Temporal, and Karla Nelson addressed the board regarding district processes.

(Rosemark and Nitardy arrived during Public Comment)

Yener moved and Livingston seconded the following resolution, which carried on a 6 – 0 vote:

BE IT RESOLVED by the School Board of Independent School District No. 622 that the following Consent Agenda Items, V.A. through V.H., be approved as written, and a copy of the agenda items is attached to the minutes.

Tartan High Student Representative Rodriguez reported on the following: As read by Student Representative Orozco, Rodriguez shared that past events included a winter band concert and a Holiday Helping Hands where Student Council students helped with distributing presents and food, both considered successful events. Sports updates included games this week for boys hockey and girls and boys basketball and a dance competition. Rodriguez recognized Superintendent Tucci Osorios' communication regarding the current ICE situation. Rodriguez also requested adoption of a similar policy to that of Edina school district where students who make light of ICE threats or publicly supported actions that targeted or harmed marginalized communities face disciplinary action.

North High Student Representative Orozco reported on the following: Orozco reported that winter sports have begun. He shared that the athletic office will be offering free admission tickets to home events in recognition of outstanding students. This week there will be a Show Choir showcase and the ASU Hmong New Year celebration. Orozco is also excited to take part in this week's spirit dress-up week. Recently NHS and Student Council took a trip to Feed My Starving Children and helped pack 23,760 meals which will feed 65 kids for an entire year. It was a reminder to Orozco of how fortunate students are to receive free lunches. MSHSL recognized two North students Lindsey Lamb and Brody Schultz. Orozco has experience with ICE operations in the communities.

Cavett & Miklausich gave a middle school presentation.

St. Michaels reviewed the following eleven policies which are proposed for revision: 306 (Code of Ethics and Behaviors); 606 (Textbooks and Instructional Materials); 712 (Video & Electronics Surveillance Other Than On School Transportation Vehicles); 722 (Public Data Request); 417 (Chemical Use & Abuse); 513 (Student Promotion, Retention, and Program Design); 519 (Interviews of Students by Outside Agencies); 601 (School District Curriculum and Instruction Goals); 616 (School District System Accountability); 621 (Literacy and The READ Act); 709 (Student Transportation Safety Policy). These policies will be proposed for action at the January 27 business meeting.

Swor moved and Niardy seconded the following resolution, which carried on a 6 – 0 roll call vote:

**RESOLUTION ESTABLISHING POLLING PLACES AND COMBINED POLLING PLACES FOR CERTAIN MULTIPLE PRECINCTS AND DESIGNATING VOTING HOURS FOR SCHOOL DISTRICT ELECTIONS NOT HELD ON THE DAY OF A STATEWIDE ELECTION**

BE IT RESOLVED by the School Board (the “Board”) of Independent School District No. 622 (North St. Paul-Maplewood-Oakdale) as follows:

1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for School District elections are those precincts or parts of precincts located within the boundaries of the School District which have been established by the cities or towns located in whole or in part within the School District. The Board hereby confirms those precincts and polling places so established by those municipalities.
2. Pursuant to Minnesota Statutes, Section 205A.11, the Board may establish a combined polling place for several precincts for school elections not held on the day of a statewide election.
3. The polling places and combined polling places described in Exhibit A to this Resolution are hereby established to serve the precincts specified for all School District special and general elections not held on the same day as a statewide election. The designations herein made shall remain in effect unless any polling place or combined polling place is subsequently changed, in which case the Board must designate, by a resolution adopted by not later than December 31, any changes to such polling places and combined polling places, as provided in Minnesota Statutes, Section 205A.11, subd. 2(b).

Yener moved and Martens seconded the following resolution, which carried on a 6 – 0 vote:

BE IT RESOLVED by the School Board of Independent School District No. 622 that the two-year salary and benefit increases for non-unit salaried employees of North St. Paul-Maplewood-Oakdale be approved.

Livingston moved and Swor seconded the following resolution, which carried on a 6 – 0 vote:

BE IT RESOLVED by the School Board of Independent School District No. 622 that the two-year salary increases for non-unit hourly employees of North St. Paul-Maplewood-Oakdale be approved.

During Board Communications, the following items were shared:

- Rosemark is excited to be starting his term as a 622 school board member. Rosemark shared she enjoyed the pho fundraiser hosted by North's BSU/LatinX/ASU clubs.
- Livingston enjoyed the show choir performance that was part of the breakfast hosted by the Rotary.

- C. Anderson enjoyed the Elf Jr production. He also wished everyone a happy holidays.

Tucci Osorio announced that because of a special election in District 47A, the board meeting would need to be moved. Swor moved and Livingston seconded the following resolution, which carried on a 6-0 vote:

THAT the January 27, 2026 business meeting be rescheduled for January 26, 2026 and begin at 6:00 PM in the boardroom of the District 622 Education Center.

Livingston moved and Swor seconded the following resolution, which carried on a 6 – 0 vote:

BE IT RESOLVED by the School Board of Independent School District No. 622 that the 2025 Payable 2026 property tax levy is adopted in the total amount of \$69,993,802.64 and, further, that the School Board Clerk is authorized to sign the document used to certify the property tax levy to the county auditors and the Minnesota Department of Education.

Nitardy moved and Yener seconded the following motion, which carried:
