Contract to provide SPEECH TELETHERAPY services to:

Annette Island School District

Services provided by - Clover Therapy Services, LLC

Services provided to – Annette Island School District, PO Box 7, 4th and Milton Street, Metlakatla, Alaska, 99926

This contract, made and entered into this _____ of January, 2022 by and between Annette Island School District, hereinafter called AISD, and Clover Therapy Services, LLC, hereinafter called Clover Therapy Services.

In consideration of the mutual covenants herein, AISD and Clover Therapy Services agree as follows:

1. AISD shall pay Clover Therapy Services, LLC, \$110 per hour. This rate shall be payable in a bi-monthly installment in accordance with accrued hours as designated via monthly invoicing from Clover Therapy Services for services rendered.

2. Clover Therapy Services' Teacher of Deaf and Hard of Hearing Teacher agrees to perform reasonable activities and assignments for the position of providing virtual and in-person (not available this year) to AISD students in accordance with the ethics standards set by the Alaska and Texas Educational Agencies and the needs of the school district. Such services shall generally be performed within dates and times prescribed in the district calendar and accordance with AISD policy.

Per AISD contractual agreement, the Teacher of Deaf and Hard of Hearing Teacher will provide approximately 5 - 15 monthly guaranteed hours on a biweekly basis.

3. AISD agrees to provide paid time for training, scheduling, documentation, and other organizational tasks necessary for the provision of quality DHH services to the students of AISD. AISD also agrees to reimburse annual AK licensure, AK licensure related continuing education, and professional liability insurance costs for the Teacher of Deaf and Hard of Hearing.

4. AISD agrees to provide an appropriate, private computer station and paraprofessional e-helper which are reasonable and necessary for the provision of Teletherapy/educational Services in a school district.

5. The term of this contract shall be for a period commencing January, 2022 and ending at the completion of the 2021-2022 school year. This contract is for the term specified in this paragraph and may be renewed or extended by written mutual agreement of the parties hereto.

6. This contract shall at all times be conditioned upon and subject to the requirements of State Licensure. Clover Teacher of Deaf and Hard of Hearing shall hold a valid license for the position of Teacher of Deaf and Hard of Hearing in the state in which he/she resides or is visiting at the time of professional teaching services rendered. The teacher shall also hold a valid certificate or license for the State of Alaska to practice as a Teacher of Deaf and Hard of Hearing (the site of services received).

7. AISD and Clover Therapy Services agree that this contract may be canceled and terminated upon 30 days' written notice for any reason.

8. AISD and Clover Therapy Services agree that notwithstanding any other provision of this contract, AISD may terminate this contract immediately for cause upon the following grounds: physical or mental disability, incompetency, neglect of duty, immorality, unsatisfactory performance, insubordination, the conviction of a felony or the acceptance of a guilty plea, a plea of nolo contendere, or a deferred sentence for a felony, or other good and just cause. At the time of termination for cause, AISD shall provide such due process as is required by the constitutions of the states and the United States.

9. Upon expiration or termination of this contract, AISD is responsible to pay for services rendered and then shall have no further financial obligation to Clover Therapy Services.
