Executive Director's Report	Professional Development Opportunities for Region One ESC Employees Ms. Barbara Grayson, Region One ESC Coordinator for the Center for e- Learning, provided an overview of the online Professional Development Opportunities available to Region One ESC employees. Ms. Grayson reported on several interactive online courses including <i>LearnKey</i> , an online video courseware that provides courses for Region One employees to enhance productivity with interactive technology lessons, hand-on practice and preparation for industry-standard testing in products including Microsoft Office and Adobe. Ms. Grayson also introduced <i>EduHero</i> , an anywhere, anytime, online professional development made by Texas educators for Texas educators. Ms. Grayson briefly introduced the use of a Distance Learning Consortium to provide distance learning capability for content, information and collaboration for internal employees as well as districts and their staffs, as well as ZOOM for collaboration and connection as a cloud-based video/web conferencing software to provide face-to-face event connection to districts, technical support and professional development in a virtual setting.
