## **Needs Assessment**

Using staff and student surveys, PDAS evaluation data, classroom grades, TEKS Resource System, TxEIS data, STAAR results, Eduphoria data, and TEA Accountability reports, the WHS site based decision making committee has found that Waskom High School is a safe and positive school with highly qualified instructors teaching TEKS driven, student-centered lesson to students. Teachers and students alike have access to many technological devices that enhance lessons and increase students engagement.

Although strong in these aspects, the committee recognized several needs that have not been fully met. Readily available technology is not always functional or updated. Data from surveys reflect that communication and collaboration are valued but not always a deciding factor in the decision making process. Staff surveys also indicate that professional development is not always relevant to the individual teacher's needs. Even though the curriculum and regular summative assessments are aligned the scope and sequence conflict with formative assessments and instructional materials. Student achievement data shows that the relationship between classroom and state assessment results are not correlated. When compared to the state averages released by TEA, campus STAAR End of Course Exam data reflect a deficit in English and Algebra I, with the largest gap being in the English II scores. Those scores also indicate a large gap in our Hispanic and African American Subgroups in those same subjects. That same data indicates a need to increase the advanced performance of our highest performing student groups as well as increase the post secondary readiness of all of our students. TEA data also indicates a need to increase the participation of our students in ACT/SAT testing as well as dual credit offerings across the campus.

Overall, Waskom High School has a positive school culture and climate and is viewed by all stakeholders as a safe learning environment where a quality, TEKS aligned education can be attained. The goal of the staff students and community of WHS is to work towards better communication and collaboration among the staff, administration, students and stakeholders of the campus. In addition the committee seeks to lessen the gap between the Hispanic and African American subgroups within the areas of English and Algebra.
