Project Status Report

Merchants Building improvements - Water bottle filling /drinking fountain has been installed. LED lighting is approximately 75% finished. Windows have been picked up and are ready to be installed as time allows.

Repairs race track fence- Old boards have been removed and replaced. We will continue to work on this project.

There are issues with the HVAC at the MDOT building and I have been informed by Control Solutions that we will need to hire an engineer to look at that system to determine the best course of action going forward. We are looking into the potential cost to get this taken care of. We have contacted an engineer who looked at some building plans we sent to him and he is working with Control Solutions to develop a plan to make the necessary repairs.

I received a call from Leslie Davis from Omni regarding the A/C not coming on for certain areas of the building. Control Solutions is working on the issues. Some repairs have been made and attached is the invoice for \$3,039.00 for the repairs that have already been completed. Also attached is a proposal for completing the necessary repairs. The repairs would total approximately \$13,400.00. I am requesting that \$16,500.00 be transferred from the 711 building fund into line item number 245-265-931 (equipment maintenance) to pay the existing invoice and complete the rest of the repairs necessary. There is \$107,000.00 available in the building fund as of 7/11/24.

Health Department circulating pump- The circulating pump for the HVAC system has developed a leak. Attached is a proposal from Control Solutions to either rebuild or replace that pump. I am requesting that \$4,500 be transferred from the Health Department building fund into line item number 246-265-931 (equipment maintenance) for the repair of the existing pump. There is \$278,000.00 available in the building fund as of 7/11/24.

Animal control roof replacement- Weather has been wet and has moved this project back. It is scheduled to begin the week of 7/15/24.
